- You can make a **designated gift** and direct your contribution to a specific scholarship, academic program, or any other special need. Designated gifts are placed in a restricted account and used only for the purpose intended by the donor.

## Payroll Deduction

When you make your gift through payroll deduction, you make a small impact on your paycheck while making a huge impact on the quality of education at Embry-Riddle.
