

# AGREEMENT FOR AEMO TO ISSUE RECIPIENT CREATED TAX INVOICES

## Parties

The AUSTRALIAN ENERGY MARKET OPERATOR LTD ABN 94 072 010 327 (AEMO), and

(herein referred to as THE MARKET PARTICIPANT), ABN .....

a registered Participant of the Western Australian Wholesale Electricity Market.

## Recitals

AEMO has agreed to issue tax invoices to THE MARKET PARTICIPANT and THE MARKET PARTICIPANT has agreed to accept those invoices in respect of supplies relating to the Western Australian Wholesale Electricity Market (WEM) and in satisfaction of the taxation requirements for Recipient Created Tax Invoices.

## Operative Provisions

### 1. General - WEM Supplies

- (a) AEMO can issue tax invoices in respect of WEM supplies made by THE MARKET PARTICIPANT;
- (b) THE MARKET PARTICIPANT will not issue tax invoices in respect of the supplies made to AEMO;
- (c) THE MARKET PARTICIPANT acknowledges that its registration status for GST is current on the day that THE MARKET PARTICIPANT signs this agreement and that THE MARKET PARTICIPANT will notify AEMO if it ceases to be registered for GST; and
- (d) AEMO acknowledges that its registration status for GST is current on the day that AEMO has signed this agreement and that AEMO will notify THE MARKET PARTICIPANT if AEMO ceases to be registered or AEMO ceases to satisfy any of the requirements for issuing RCTIs listed in the Commissioner's determination as set out in Goods and Services Tax Ruling 2000/10.

### 2. Effective date

### 3. Termination

The agreement will continue until the first to occur of:

- a) Notice of Termination of the agreement issued by either THE MARKET PARTICIPANT or AEMO to be advised in writing signed by the Managing Director or Chief Executive Officer of AEMO or THE MARKET PARTICIPANT or any person acting in the place of or performing duties of either of those officers. This Notice of Termination will be subject to cessation of Rule Participant registration status according to clause 2.32.7 of the Wholesale Electricity Market Rules.
- b) Breach of any of the conditions in: 1(b), 1(c) or 1(d) listed above.
- c) Cessation of registration for GST by either AEMO or THE MARKET PARTICIPANT.
