Events 4 and 5 are doubles. Event 9 is a sandpaper round robin with four players in a group, winners advance into single elimination. Event 9 matches are best of 3, games to 21 serve by 5. Event 10 is a handicap event. Event 10 matches are best of 1 game, games to 31 serve by 2.

General Information: All USATT regulations apply: Clothing must NOT be solid orange in color in reference to the USATT Dress Code. Non-scutting soft sole shoes must be worn. Shoes must NOT leave marks on the floors. Rackets must have ITTF approved rubber, one side red, one side black. All food and beverages (except for water) must be kept off playing court. Sitting area available.

Equipment: Only USATT approved equipment will be used: 18 tables and 18 nets, 40mm 3-Star Orange Nittaku Balls sponsored by Paddle Palace, wood gym floor, excellent lighting, and spacious playing area.

Eligibility: Players must be current USATT members for all events. Juniors must be born after 1/1/1994. Cadets must be born after 1/1/1998. Only USATT approved equipment may be used. **Those over 18 years of age who have never been USATT members, may purchase a playing permit for \$10 to USATT events.**

Note: Players need to report to the tournament desk at least 15 minutes prior to event. Players may enter as many events in which they qualify and/or have the stamina for and desire to play. **Guaranteed cash prizes, unless a low turnout, in this case event will be cancelled.**
