Rules for 2014 AFBF YF&R Leadership Conference Competitive Event

Background

The Collegiate Discussion Meet is a competitive event promoted by the American Farm Bureau Federation (AFBF) Young Farmers & Ranchers (YR&R) Committee. Farm Bureau's strength depends on its members' ability to analyze agricultural issues and decide on solutions that best meet their needs. The competitive event is designed to simulate a committee meeting where discussion and active participation are expected from each committee member. Applicants build basic discussion skills, develop a keen understanding of important agricultural issues and explore how groups can pool knowledge to reach consensus and solve problems. A successful applicant is a productive thinker rather than an emotional persuader. He/she will assist the group in creating ways to implement the solutions discussed and highlight Farm Bureau's involvement in those actions/steps. It is recommended that state Farm Bureaus provide, as part of the state recognition award, an expenses-paid trip to the AFBF YF&R Leadership Conference held in 2014 in Virginia Beach, Va. The AFBF YF&R Committee and the AFBF Organization Department will coordinate the program at the national level.

Information about the Discussion Meet applicant is requested on the entry form. ALL INFORMATION IS HANDLED IN STRICT CONFIDENCE AND IS DESTROYED AFTER JUDGING IS COMPLETED.

Eligibility

- Applicant shall be a member of a recognized collegiate Farm Bureau chapter or club as set up by a state Farm Bureau and be between the ages of 18 and 35. The individual shall not have reached his/her 36th birthday by Feb. 28.
- Applicant must be an undergraduate college student in a state with a recognized YF&R program. Undergraduate status is determined at the time the
 applicant qualifies for the national competitive event, not necessarily the national event itself.
- · Applicant shall not be enrolled in a graduate level program at the time of his/her state Collegiate Discussion Meet competitive event.
- Applicant must display a sincere interest in the agricultural industry.
- Applicant may only compete in one national YF&R Competitive Event per year.
- Past and present members of the AFBF Young Farmers & Ranchers Committee and/or their spouse/spousal-equivalents are not eligible to compete.
- Past state YF&R Collegiate Discussion Meet winners and/or previous AFBF Collegiate Discussion Meet competitors are not eligible to compete.
- Past state YF&R Discussion Meet winners and/or previous AFBF Discussion Meet competitors are not eligible to compete.
- Current employees of county, state and/or American Farm Bureaus and their affiliates are not eligible to compete.
- Professional speakers are not eligible to compete. Professional speakers are those who have received a fee, royalty or honorarium for speaking (i.e., paid speaking appearances or speaking engagements) within 24 months prior to this annual competition. This excludes reimbursement for travel or expenses attendant to the appearance.
- Each state may submit two entries to be considered for national recognition and must use the AFBF entry form and application. AFBF reserves the right to adjust the number of competitors based on the total number of entries.

Entry Form & Application Guidelines

- The application must be properly signed with no additional pages, including letters of recommendation, scrapbooks or other visual additions.
- States have permission to reproduce the attached entry form.

Note: Disregarding any of the guidelines listed above will result in disqualification.

Competition

- The participants will discuss pre-selected topics with four, fundamental bases for the general discussion: cooperation, constructive criticism, problem solving and communication.
- The competitive event will consist of four rounds: two Round Robins, Sweet 16 and Final Four.
 - o All competitors will compete in the first two rounds. The top 16 competitors based on judges' scores will move on to the Sweet 16 round.
 - $\circ \ \ \text{The top competitor in each of the third round rooms will move on to the Final Four round in order to determine the winner.}$
- Each round will begin with a 30-second opening statement and end with a one-minute closing statement by each participant.
- Participants will have 20 minutes of open discussion, followed by one minute of quiet time.

State Advertisement of National Awards

State Farm Bureaus are required to advertise the national prizes **one** time during the year through a print advertisement or an article in the state's publications. These promotions will qualify the state entries to receive the national prizes, should they be the winner or finalist of one of the national competitive events. The advertisement and/or article submitted **must be specific** to promoting YF&R Competitive Events and must recognize the sponsors.

PowerPoint Competitor Template

PowerPoint competitor templates that highlight the state entry must be completed using the template provided by AFBF. This template is available from the state YF&R coordinator. It should include the applicant's bio written in third person and 2-3 pictures of the applicant and his/her agricultural operation or involvement. *All pictures and presentations become property of AFBF*.

Deadline

States are encouraged to select their entries in time for recognition at their state annual meeting. Each state's entry forms and applications, PowerPoint slides and proof of state advertisement of national awards must be emailed to **angelab@fb.org** and time stamped on or before **11:59 p.m. EST Dec. 10, 2013**, to be considered for national recognition and awards.
