

APPLICATION FOR VEHICLE LOGBOOK

- **All Log Book applications must be accompanied by a completed Technical Inspection Form.**
- **ANDRA Log Books are valid for a period of two years from the month of issue.**
- **A current ANDRA Log Book is required for**
 - All dragsters / alteredes / funny cars.
 - All sedans running quicker than 11.00 (1/4 mile or equivalent).
 - All modern street vehicles built after 01/01/2008 running quicker than 10.00 (1/4 mile or equivalent)
 - All unmodified factory-built motorcycle quicker than 9.50 seconds (1/4 mile or equivalent)
 - All other motorcycles quicker than 10.00 seconds (1/4 mile or equivalent).
 - All motorcycles with a modified swing-arm, frame or brakes.
 - All Exhibition vehicles in any category.
 - Any other vehicle deemed necessary by ANDRA Officials.
- **Log Books will only be issued to current ANDRA Full Members or Associate Members in the case of Super Street licences.** Where details of a Partner/Co-Owner are required in the Log Book, that person must also be an ANDRA Full Member and must also sign the form.
- **Only one current ANDRA Log Book is permitted for each vehicle.**
- **All current ANDRA Log Books applying to the vehicle for which this application is being made must be returned to ANDRA with this application form.** Expired logbooks will be cancelled, and will only be returned to owner if requested.
- **In the case of any major alteration to the specification of the vehicle, or any change in the details of its legal ownership, the Log Book must be returned to ANDRA for amendment or replacement.**
- **Amendments to an ANDRA Log Book, or the details recorded therein, may only be made by the ANDRA Office, on receipt of written confirmation from the legal owner of the vehicle.**
- **Junior Dragster vehicles must be registered in a Parent/Guardian name who must be a current full ANDRA member.** There is no charge for a Junior Dragsters logbook. Junior Dragsters must pay a **\$44.00** Technical Inspection Label fee.
