Any individual servicing any system containing refrigerant (e.g., Freon) must be CERTIFIED, in accordance with EPA SECTION 608, in the handling of refrigerants by passing the EPA approved Section 608 examination. If an employer knowingly allows or directs employees to service any air conditioning system or appliance without this certification the Employer and Violator are SUBJECT TO A FINE OF \$27,500.00 per incident. In addition, the EPA OFFERS A BOUNTY OF \$10,000.00 TO ANY INDIVIDUAL REPORTING THE ILLEGAL ACTIV-ITY UNDER THIS LAW. Any person using Air Conditioning Gauges without this certification is in violation.

### WHAT THIS COURSE COVERS

This class will prepare you to take and pass the EPA 608 Universal Examination. Trainers will spend the first 6 hours preparing the students for the exam. Virtually every question that can be asked on the Type I, Type II and Type III exam will be covered in class. Student will be prepared to test for the Universal Certification. If a Universal Certification is achieved a technician can legally work on any air conditioning or refrigeration system no matter how large or for what application. The class will conclude with the required 2 hour EPA exam.
