TERMS AND CONDITIONS

This Agreement is made for the benefit and protection of both the new owner(buyer) and the breeder(seller) to guarantee that the new owner receives a healthy puppy upon purchase and that the puppy will have a stable, permanent home. By purchasing a puppy from Southern Doodles, you agree to the following:

- 1. A puppy is defined here to be a Toy Poodle puppy which is in good health at the time of sale, and embodies the characteristics of the Toy Poodle breed. This puppy is purebred, from a registered litter, and is registerable with the American Kennel Club (AKC). BUYER has been provided with all necessary papers for a LIMITED AKC registration for their puppy.
- 2. BUYER agrees to have the puppy spayed/neutered before the puppy is 6 months of age.
- 3. The puppy is free of known contagious diseases (This does not include umbilical hernia or worms, which are not genetic and common in puppies), has had vaccinations required for its age, and two treatments for worms at the time of this agreement.
- 4. SELLER makes no guarantee regarding loss of the dog because of accidental death, theft, sickness, etc., or any other loss beyond SELLERS control. If the dog develops hip dysplasia or life threatening genetic defects within 24 months from the date of birth, BUYER may return the dog to the SELLER for a replacement puppy of equal value. SELLER reserves the right to have a second veterinarian of her choice evaluate the dog's condition before the warranty will be honored. BUYER may elect to keep the dog. Under no conditions and at no time during the life of the dog will SELLER pay or assist in paying veterinary expenses after the dog is purchased, including any such expense directly or indirectly related to any inheritable/genetic defects.
- 5. We do not guarantee the size, color, breeding or show potential of your new puppy.
- 6. BUYER certifies by signing this agreement that the dog will have adequate exercise, nutritious food and necessary health care from a licensed Veterinarian, BUYER also certifies, by signing this agreement, that the BUYER will not sell or give this puppy to a pet store, kennel, pound, guard dog business or a medical research facility. The BUYER agrees to contact the SELLER should the BUYER be unable to properly care for or keep the puppy at any time during the puppy's life.
