Church Activity Participation: Permission, Waiver Release & Indemnification Agreement

By signing in the NOCBC Activity Attendance Form, I agree to the following:

I wish [I wish my child] to participate in activities made available by New Orleans Chinese Baptist Church (NOCBC) at the church facilities on 3413 Continental Drive, Kenner, LA 70065. The activities include but are not limited to sports activities such as basketball, volleyball, badminton and table tennis, and/or other activities that may be hazardous or otherwise involve a risk of physical injury or death to participants. I [my child] will obey the rules and regulations set forth by the NOCBC to promote harmony in church activities, uphold safety for me [my child] and other participants, and safeguard church properties. The NOCBC reserves the right to refuse participation of church activities to me [my child] if I [my child] violate(s) NOCBC rules and regulations for safety reasons. I understand that this agreement also pertains to transportation provided by the NOCBC and its representatives to and from the church for my [my child's) benefit. I expressly assume any and all risks of injury or death arising from or relating to the activities and waive and release any and all actions, claims, suits or demands of any kind or nature whatsoever against the NOCBC, it's pastors, officers, members, volunteers or representatives of any kind (collectively termed the Releasees) arising from or relating in any way to my [or my child's] voluntary participation in NOCBC church activities. I understand that this Permission, Waiver, Release & Indemnification Agreement means, among other things, that if I am [my child is] injured or deceased as a result of my (or my child's) participation in any of the activities, I and/or my family or heirs cannot under any circumstances sue the Releasees for damages relating to or caused by my [my child's] injuries or death. I agree to indemnify the Releasees, and their subrogates if any, in the event of any loss, damage or claim arising from or relating in any way to my [my child's] participation in any of the church activities. I understand and agree that I [my child] would not have been permitted to participate in any of the church activities had I not executed this Permission, Waiver, Release & Indemnification Agreement. In the event of an emergency, I hereby authorize the coordinators of the church activities, as an agent for me [my child], to consent to: any X-ray examination; medical, dental or surgical diagnosis; treatments; or hospital care advised and supervised by a physician, surgeon or dentist (as appropriate) licensed to practice under the laws of the state where services are rendered, either on site at the NOCBC, at a doctor's office or in a hospital. I expect that my family will be contacted as soon as possible. I have read this Permission, Waiver, Release and Indemnification Agreement, have asked and received answers to any questions I had concerning its meaning, and execute it freely, without duress, and in full and complete understanding of its legal effect, and of the fact that it may affect my legal rights.
