Due to recommendations and requirements of the Missouri Fire and Rescue Training Institute, Firefighters of the Winfield/Foley Fire Protection District shall not grow a beard, sideburns, or lengthy hair styles that may interfere with a proper face piece seal of Self-Contained Breathing Apparatus.

Due the possibility of burns and other injury, the Winfield/Foley Fire Protection District does not allow any Junior/Cadet to wear head jewelry at anytime when on duty or performing functions for the fire district.

The Winfield/Foley Fire Protection District requires that members of the Junior/Cadet Firefighter program maintain their educational training through their school. The Fire District does not wish for member activities with the junior/cadet program to deter from their formal education. Members are required to maintain good grades. Poor grades are grounds for dismissal from the Junior/Cadet program.
