  - a) **Matriculation/School Leaving Certificate indicating date of birth.** The candidate, who has not submitted earlier the age proof mentioning date of birth, must produce it in original at the time of the interview.
  - b) **Degree/Post Graduate Diploma/Degree certificates, mark sheets** of the examinations passed along with the **attempt certificate**.
  - c) Certificate of completion of **Compulsory Rotating Internship**.
  - d) Certificate of **Registration with the Medical Council of India/State Medical Council**.
  - e) Certificates/documents in support of experience claimed, duly signed by Head of Institution (s)/ HOD with rubber stamp, clearly indicating the period with date, month & year of employment and the nature of work performed.
  - f) Employed candidates who have not already submitted "**No Objection Certificate**" from their employer(s) or whose applications are not forwarded by the employer(s), are required to bring the same at the time of the interview, failing which they may not be interviewed.
  - g) Candidates applying for the reserved vacancies are required to bring, in addition to the above, **SC/ST/OBC certificate (as the case may be) in the prescribed form. The OBC certificate should be issued in the last one year with certificate regarding creamy layer.**
