Hotel reservations will only be confirmed by the ESC upon receipt of the deposit payment (see payment section). Upon presentation of the voucher to the Hotel, the deposit payment will be deducted from the Hotel invoice.

Confirmations are sent by e-mail. If you do not receive any confirmation within 14 days, it is your responsibility to check back with the ESC. Your request and acceptance of our conditions is considered firm and the cancellation conditions apply as soon as a room has been booked.
