Removing the Myths about Graduate School

It's nearing the end of the school year and time for many of you to start thinking about taking classes to renew your teacher certification and/or work on completing your master's degree. As we near the time for classes to start, we often receive a number of questions about the application to graduate school and registration processes. The purpose of this article is to answer a number of those questions for you.

Application to Graduate School

To enroll in graduate school classes at West Virginia University, you must be an "active" graduate student. To become an active graduate student you must complete an application and pay the \$50.00 nonrefundable service fee. Here you are faced with your first choice: do you apply to WVU online or use the traditional paper application. Degree or Non-Degree Status

Once you start the application forms you are faced with a second choice. Are you pursuing a degree or do you want to be admitted as a non-degree student? A non-degree student is someone who is only interested in taking courses and has no interest in completing a degree. Someone who is only interested in working on the plus 15, plus 30, or plus 45 hour endorsements fits this category. The advantage of the non-degree option is that your status will never become inactive forcing you to reapply and pay the service fee again. The disadvantage of the non-degree status is that if you change your mind, no more than twelve "non-degree" hours can be applied to a degree program.

Acceptance Process

If you decide to register as a degree student, you must be formally accepted into the program. Each program has its own criteria but most programs will have a minimum GPA (2.50 – 2.75), require the Graduate Record Exam (GRE or GMAT), require a "purpose statement" and/or require letters of recommendation.

Once you start a degree program you will have a specific time limit to finish the degree (usually seven years) and an expectation that you will take courses on a regular basis. If you fail to take a least one course in any twenty-four month period, you will be dropped from the "active" status. To enroll in courses and continue the program you will have to reapply to the program and pay another service fee.

An application can take up to four to six weeks to process. When the Office of Admissions and Records determines the applicant meets minimum university standards, the application is sent to the respective College. The College forwards the application to the Division and the Division sends it to the Department. The student must be accepted by the Department before he/she can take courses.

Keep the following items in mind as you formulate your plans.

1. Once you complete a graduate degree you must submit a new application and pay the nonrefundable service fee to take additional courses.
2. Students may transfer credit from other institutions accredited regionally at the graduate level, however, there is a limit of twelve hours (programs requiring 30-41 hours) that may be accepted for credit.
3. Non-degree graduate students are not permitted to transfer credit to WVU from another institution.

Professional Development and S/U Credits

Professional development credit (designated by a 900–950 course level) is available for professionals seeking graduate credits, but not pursuing a degree. Professional development credit cannot be applied to a graduate degree. Courses graded "pass-fail" will not count toward a graduate degree. Courses graded "satisfactory or unsatisfactory (S/U)" must be approved by the associate provost for academic programs.

Plan of Study

Early in your program, usually by the completion of six to nine credit hours of gradu-

ate coursework, you and your advisor will draw up a plan of study to show the student's direction. This plan of study becomes a part of the student's record and constitutes, with some degree of specificity, the terms and conditions that the student must meet for completing the degree requirements. Subsequent changes in the plan of study must be approved by the student and the advisor.

Master of Science in Agricultural and Extension Education

The Master of Science in Agricultural and Extension Education is designed for professionals in agricultural and extension education, including individuals interested in international development. A minimum of thirty hours is required for the completion of the degree including twenty-four hours of coursework. The coursework includes courses in research methodology and statistics. A research thesis is also required. Thesis topics of graduate students are primarily focused on understanding and solving problems in the broad fields of agricultural and extension education.

Master of Agriculture, Forestry, and Consumer Sciences

The Master of Agriculture, Forestry, and Consumer Sciences degree requires the completion of thirty-six hours of graduate-level coursework. A minimum of eighteen hours must be selected from among graduate courses available within two divisions of the Davis College, with no fewer than six hours in either division. No more than twelve hours of special topics or independent study may be counted towards the degree.

Directions to Potomac State College of WVU are as follows:

From Morgantown, take I-68 East to Cumberland, MD. At Cumberland, take Exit 42 (Greene Street) to Route 220 South. Route 220 South will bring you into Keyser, WV, (approximately 20 miles from Cumberland, MD). Once in Keyser, turn right on to State Street (5th street on your right) follow the street to the top of the hill at Church McKee. Parking will be available in the parking lot to the left of the building.

Program

The contest will possibly include 2-4 halter classes, with a set of oral reasons on one or two classes; and possibly 2-3 performance classes with oral reasons on one of them. This could make a total of 2-3 oral reasons for seniors. Notes will not be allowed when presenting oral reasons.

Scoring

We will implement the same scoring computer program for the State 4-H and FFA Contest. Please note: Important!! Contestants must possess two #2 pencils and clipboard for marking scantron scoring sheets. Make certain that contestants darken the correct placing for the class they are evaluating. Don't mark Class 1 if you are starting with Class 2. All possible sections for placing class are located from top to bottom under each class. On placing classes (Halter & Performance) - darken in your choice for the placing of the class. This section is located in the upper right hand corner of the scantron sheet.

Specific Rules:

A. Classes: All classes will consist of four horses. Halter classes will be numbered 1, 2, 3, and 4; left to right from the rear. Riders of performance classes will have an exhibitor number (1, 2, 3, and 4). Fifteen minutes will be allowed to place halter classes and ten minutes to place performance classes.

B. Performance horses will be shown at a walk, trot, canter, and at a hand gallop in the case of English Pleasure. The horse will also be asked to back and stand quietly. Horses should be judged on manners, way of going, and response to the rider.

C. The four animals in each class will hopefully be of the same breed, sex, and appropriate age. Some classes may be mixed, via sex or ages depending upon donor horses available.

D. The contest officials will attempt to select only horses that are serviceably sound. All halter classes will be judged as sound of limb, eye, wind, and mouth. Performance horses will be judged as seen (unsoundness to be penalized accordingly). All tack and attire is considered legal.

E. Breeds that may be included at the contest:

Halter - Quarter Horses, Arabians, Appaloosa, Paso Fino, Draft Breeds, Miniature Horses, and Thoroughbreds

Performance - Western Pleasure, Hunter Under Saddle, Saddle Seat Pleasure, Hunter Hack. Also possibilities could be Western Horsemanship and Hunt Seat Equitation however these would not be reasons classes.
