- 3. If you were an Israeli citizen during your studies you must provide a list of your entries and leavings from the Ministry of Interior.
- 4. Passport and ID (if there is).
- 5. If your university <u>was not</u> recognized by us, you will be requested to provide further documentation: letter of confirmation from the official ministry of the state where you studied, stating that the university is authorized to teach law; letter of confirmation from the foreign Bar that someone with your diploma is entitled to open a process for his/her admission to the Bar. (see the appendix for examples).
 - We can inform you whether a specific university had been recognized by us.
- 6. You will be requested to leave in our offices <u>a copy</u> of all the documentation detailed above.
- 7. Application form (can be filled in our offices).
- To your attention: we reserve the right to ask for documentation not listed above, in accordance with our discretion and the criteria for our work. Nothing in this explanatory information may constrain our discretion.
