1.0 PRE-QUALIFICATION INSTRUCTIONS.

1.1 Introduction

Kenya Industrial Estates Ltd would like to invite interested candidates who must qualify by meeting the set criteria as provided by the Procuring entity to provide a panel of **SPECIALISED SURVEILLANCE EQUIPMENT (CCTV CAMERA E.T.C.) AND RELATED SERVICES SERVICE PROVIDERS.**

1.2 DESCRIPTION OF THE REQUIRED SERVICES

Description of Services to be provided:-

After prequalification and upon competitive bidding amongst the prequalified bidders, the qualified firms will be expected to:-

- a. Offer to **KENYA INDUSTRIAL ESTATES LTD** trainings on enterprise risk management and related subjects.
- b. Offer to **KENYA INDUSTRIAL ESTATES LTD** trainings on Credit management and related subjects.
- c. Prepare enterprise and credit risk managements documents on behalf of **KENYA INDUSTRIAL ESTATES LTD**.
- d. To develop risk management tools for the Company.
- e. To develop credit policy tools and manuals.
- f. To assist the Company in the process of risk identification, Assessment and Measurement

1.9 Additional Information

The Company reserves the right to request submission of additional information from prospective bidders.

1.10 Invitation to Tenders / Quotations.

Bidding documents (Tender/Quotations) will be made available as and when required, **ONLY** to those bidders whose qualifications are accepted by Company after completion of the pre-qualification process. It is **KENYA INDUSTRIAL ESTATES LTD's policy** to require that tenderers observe the highest standard of ethics during the selection and execution of such contracts. In pursuance of this policy, **KENYA INDUSTRIAL ESTATES LTD;**

- a) Defines, for the purpose of this provision, the terms set forth below as follows:
 - **"Corrupt practice"** means the offering ,giving, receiving or soliciting of anything of value to influence the action of an officer of the Purchaser in the pre-qualification process; and
 - **"Fraudulent practice"** means a misrepresentation of facts in order to influence the pre-qualification process to the detriment of the purchaser.
- b) Will reject a tender for pre-qualification if it determines that a Tenderer has engaged in corrupt or fraudulent activities in competing for the contract in question;
- c) Will declare a Tenderer ineligible, for pre-qualification if at any time it determines that the Tenderer has engage in corrupt or fraudulent practices in competing for, or in executing similar contract.
- d) Will have the right to inspect the tenders accounts and records relating to the performance of services in this tender.
- e) Will have the right to inspect the business premises of the tenderer. They shall furnish information as described in the prequalification document.

2.0 PRE-QUALIFICATION DATA INSTRUCTIONS

2.1 Pre-Qualification Data Forms

- 2.1.1 The attached questionnaire forms **PQ-1**, **PQ-2**, **PQ-3 AND PQ-4** are to be completed by prospective suppliers/contractors who wish to be pre-qualified for submission of tender.
- 2.1.2 The Pre-qualification application forms which are not filled out completely and submitted in the prescribed manner may not be considered. All the documents that form part of the proposal must be written in the English language and in ink only.

3.4 QUALIFICATIONS

- 3.4.1 It is understood and agreed that the pre-qualification data on prospective bidders is to be used by Company in determining, according to its sole judgment and discretion, the qualifications of prospective bidder to perform in respect to the required legal services as described by the client.
- 3.4.2 Prospective bidders will not be considered qualified unless in the judgment of Company they possess capability, experience, qualified personnel available and suitability the working capital sufficient to satisfactorily execute the needed legal services.
