Fiscal and Economic Impact, including Statement of Cost of Compliance:

After consulting with the Fixed Site Scheduling Advisory Committee, Oregon OSHA has concluded there is no overall fiscal impact to employers or to the agency as a result of the proposed changes to the scheduling of safety inspections for fixed places of employment procedures in Division 1. Oregon OSHA's own costs in administering the rule are limited to the rulemaking itself. To the degree the scheduling system and the enforcement activity it generates have a cost to the agency, they are costs that would have been incurred under the previous scheduling system. Although different employers may be selected for inspection based on this revision, the rules being enforced will not change nor will the total number of inspections or the manner in which they are conducted change. Therefore, the overall

impact to employers will be unchanged. The major change to the scheduling procedures is in how the calculation is completed using a statistical weighting method involving t-scores which may mean that employers may be inspected in a different order than they otherwise would have been.

All state agencies are affected by the rule in the sense that they are employers under the Oregon Safe Employment Act (OSEAct). However, state agencies other than DCBS/Oregon OSHA will have no costs under this rule other than those they would occur as an employer. Similarly, local governments are affected by this rule only in the sense that they are employers under the OSEAct. Finally, the public as a whole will be affected only to the degree that members of the public are employers and employees.

The net effect on employer costs will be neutral, with some employers experiencing a non-significant increase in costs and some employers experiencing a non-significant decrease in costs. Both cost differences experienced due to the time spent during an inspection.

Similarly, all small businesses in the state that employ workers would potentially be affected by this rule change, except those in construction and forest activities. Based on data obtained from the Employment Department, Oregon OSHA estimates that as many as 96 percent of the affected employers are small businesses with fewer than 50 employees. This procedure for compiling new lists will not represent a change in the balance of size of employers as the lists will represent the same population affected by the current rule. The rule does not require any new reporting, recordkeeping or other administrative activities of small businesses (or of other businesses). The rule does not require purchase of new equipment, supplies, labor or increased administration.

There will be no fiscal impact with amending the Recordkeeping for Health Care Assaults rule to remove the reporting requirement which has been satisfied.

How were small businesses involved in the development of this rule?

The Fixed Site Scheduling Advisory Committee met May 13, 2011. Representatives invited included members of manufacturing businesses, the construction industry, city/county services, councils and associations that speak for businesses both large and small, and union leaders. It is not anticipated that small employers will be affected any differently than large employers.
