Course Description:

This course prepares participants to establish and sustain an active local CERT program.

Course Goal:

This course defines the core components of a local CERT program and focuses on effective practices for:

- 1. Developing local CERT program goals and a related strategic plan
- 2. Promoting local CERT programs
- 3. Orienting, managing and retaining CERT members
- 4. Recruiting, funding, managing, and retaining CERT trainers
- 5. Acquiring and managing program resources
- 6. Delivering and managing effective training and exercises
- 7. Developing policies and procedures for operating a local CERT program
- 8. Evaluating and sustaining the program

Prerequisite:

Participants in this course must have:

- 1. A referral from a CERT-sponsoring agency, typically a Local, Regional, or State government agency
- Completed the CERT Basic Training course or IS317: Introduction to CERT (http://www.citizencorps.gov/cert/IS317/)

Course Length:

2 days

Target Audience:

The audience for this course includes professionals and volunteers who are designated to be or are local CERT

Program Manager or for those already in a CERT Program Manager position.
