WHEREAS THE TOWN OF BELLMONT HAS LOST THE RAGGED LAKE CULVERTS ON BRYANTS SIDING ROAD ON THE NIGHT OF APRIL 15TH , 2014 DUE TO EXTREMELY HIGH FLOOD WATERS ON RAGGED LAKE OUTLET CAUSING THE ROAD TO BE CLOSED, AND WHEREAS THE TOWN SUPERVISOR HAS FILED A STATE OF EMERGENCY DECLARTION WITH FRANKLIN COUNTY DUE TO THIS EVENT, AND.

WHEREAS THE GOVERNOR OF NEW YORK STATE HAS DECLARED A STATE OF EMERGENCY FOR SEVERAL NORTHERN NEW YORK COUNTIES, INCLUDING FRANKLIN COUNTY.

HIGHWAY SUPT.'S REPORT:

+WE HAVE ABOUT 1500 YARDS OF SAND LEFT OVER IN BELLMONT CENTER THAT WE WILL HAUL UP TO OWLS HEAD FOR NEXT YEAR.
+THE COLD PATCH I ORDERED FROM BEGOR SUPPLY CAME IN LAST MONTH.
+WE HAVE HAD MAJOR FLOOD DAMAGES OCCUR TO THE RAGGED LAKE OUTLET ON THE BRYANTS SIDING ROAD. THANKS TO THE QUICK ACTION OF THE COUNTY HIGHWAY DEPT. THE BRIDGE HAS BEEN TEMPORARILY FIXED FOR TRAFFIC TO PASS.
+WE SHOULD BE RECEIVING AN INCREASE OF ABOUT \$16,000 TO \$19,000 IN CHIPS FUNDING FOR THIS YEAR.

TOWN SUPERVISOR'S REPORT:

*THE RECENT ADIRONDACK GOVERNMENT DAYS WAS ATTENDED BY JUDYLANE NASON, ANN PERRY, WAYNE ROGERS, JACK PERRY, AND ME ON APRIL 10TH IN LAKE PLACID. THIS WAS, I THINK, ONE OF THE BEST ONE DAY SESSIONS THEY HAVE PRESENTED. VERY HELPFUL.

*ADIRONDACK TOBACCO FREE NETWORK NEWS LETTER HAS ARRIVED.

*HAVE MET AT RAGGED LAKE OUTLET CULVERTS WITH EMERGENCY SERVICES DIRECTOR RICKY PROVOST, FIRE DEPT. PRESIDENT PETER TEABEAU, COUNTY HIGHWAY PERSONNEL, NYS FEMA REPS TO DISCUSS EMERGENCY REPAIR AND RECORD KEEPING. THE SUPPORT WE HAVE RECEIVED FROM THE COUNTY HAS BEEN EXCEPTIONAL, WE REQUESTED BULLDOZER, IT WAS LOADED AND DELIVERED WITH A DRIVER WITHIN 75 MINUTES, EXCAVATOR AND DRIVER PLUS LABORERS DELIVERED THURSDAY TO STABILIZE THE ROAD AND CULVERTS TO ESTABLISH A ONE LANE TEMPORARY BRIDGE FOR RESIDENTS USE. ROAD OPENED TODAY AT NOON.

*RESIDENTS HAVE RESPONDED WITHOUT QUESTION WHEN THEY WERE CONTACTED TUESDAY NIGHT AT ABOUT 9:15 PM AND AGAIN AT 5:30 AM ON WEDNESDAY TO LET EVERYONE KNOW THE BRIDGE WAS DESTROYED AND THEY WOULD HAVE TO TRAVEL THE DOMTAR LOGGING ROAD.

*WORKING WITH THE DAM KEEPERS ON A DAILY BASIS AT BOTH LAKE AREAS TO MONITOR DAM CONDITIONS AND WATER LEVELS.

*THE NYS MEETING OF SUPERINTENDENTS OF HIGHWAYS WILL BE HELD IN ITHACA, N.Y. ON JUNE 2ND TO 4TH AND OUR HIGHWAY SUPERINTENDENT SHOULD ATTEND. TOTAL COST WILL BE IN THE ABOUT \$500 TO \$600. WE CAN SEND THE REGISTRATION CHECK FOR \$100 AND THEN WE CAN GIVE LEE A CHECK FOR \$500 WITH THE UNDERSTANDING THAT HE WILL RETURN RECEIPTS AND ANY UNUSED MONEY TO US WHEN HE RETURNS.
