

**Berkshire County, Massachusetts
Town of Becket
Harbor Master
Rules and Regulations Regarding
Moorings, Floats and Rafts
As of June 1, 1993**

1. No mooring or float may be placed farther than 50 feet from shore without approval of the Harbor Master.
2. No mooring or float shall be placed so to obstruct a right-of-way.
3. Floats or rafts, bottom anchored, are limited to one per household. They must be approved by the Harbor Master.
4. Floats or rafts must have reflectors on all 4 corners, at least 3 inches in diameter, and should be of white or yellow waterproof material, and be visible at least 8 inches above the water.
5. Boats must be secured to an approved mooring or fixed dock only.
6. Each person placing a mooring, float, raft, or dock shall be solely responsible for their maintenance and they must ensure that they are properly secured.
7. No steel drums or barrels that were previously used to contain any classified hazardous chemicals will be allowed.
8. All moorings, floats, and rafts shall be permitted annually by the Harbor Master and shall be deemed a hazard if not permitted and subject to removal per M.G.L. Ch. 91, Section 10A and are not to be considered grandfathered in under any past regulations or laws.
9. All rafts, floats, and moorings must be removed prior to ice setting in, so as not to be broken loose or torn apart by shifting ice.
10. Moorings must be approved by the Harbor Master as to type and amount of weight, mooring float and size and weight of vessel to be moored.
11. Floats or rafts must have the permit number displayed on 2 sides, opposite of each other, with a blank spot for renewal sticker. Numbers must be at least 3 inches high. Permits are for 1 year and must be renewed each year. Permits are only valid to December 31st of each year.
12. 323 CMR 102:19, no rope or line shall be passed across the water to floats or rafts.

Permit fee of \$10.00 (payable to Town of Becket) must accompany application.
