

## IUD Theory Training – 2016

What will be covered in the theory session:

- current information about available IUD, managing problems,
- practice consultations and practice insertions (in pelvic models)
- pre-reading is provided

**NB:** *If you want to become competent to insert IUDs in women, an additional clinical component will be needed, and is available through Sexual & Reproductive Health WA (SRHWA) Clinical Services. All IUD clinic applicants are to complete the Clinical Practicum Application Form that details their experience and qualifications. The Medical Educator will approve applications, and successful applicants will be advised to contact the Clinic Admin Officer for placements. The Medical Educator will communicate with any applicants who have been unsuccessful for a clinical practicum. For clinical placements, SRHWA requires that doctors obtain their own medical indemnity insurance.*
