077 - New Play Equipment Proposal for Smeeton Road Area

It was noted that the result of the determinations of the solicitor advising KBPC on the legality of the Covenants relating to Smeeton Road Recreation Ground may have an implication on future installations. The Clerk wa requested to liaise with Cllr Stocks

078 - Clerks Report on actions arising from and since the last meeting

The Clerk reported that all recreation grounds and play areas were in reasonable condition and had been checked regularly. All areas were waterlogged and the rubber play area surfaces were particularly slippery due to moss and fallen leaves. This may need to be addressed later in the season. However, the Clerk was able to report no apparent damage or vandalism.

ROSPA inspections will take place during April, and the Council will receive a report on its findings.

The Clerk advised the Committee that KBPC had commissioned a tidy-up of the verge along the footpath between Hillcrest Avenue and Warwick Road recreation ground.

He reported also on an injury sustained by a dog from litter discarded in the area of the Warwick Road car park.

It was resolved unanimously that the Clerk should:

- (i) Commission CGD Contractors to undertake a deep clean of the Warwick road car park hedge and area if a quotation of less than £400 is received from them for this work (Proposed Cllr Garratt; Seconded Cllr Holyoak)
- (ii) Check the Insurance Cover of Steve Brown in dealing with potentially harmful discarded refuse
- (iii) Contact HM Lowdham Grange to investigate potential community projects to tidy the Warwick Road car park area
- (iv) Arrange with the Street Orderly for a de-littering of the path from School Road to the Tin Bridge alongside the railway
