4. Take the completed worksheet, **IRS Tax Return transcripts**, and any other documents Midland College needs to the Financial Aid Office.
5. Your financial aid administrator will compare information on this worksheet and any supporting documents with the information you submitted on your application. You or the Financial Aid Office may need to make corrections electronically or by using your SAR.
