This Fund may be added to through gifts and contributions at any time and the Fund Agreement will apply to all future gifts and bequests regardless of the source. The fund may have insufficient current and accumulated income (within the meaning of the Connecticut Uniform Management of Institutional Funds Act) in a given year to distribute the amount otherwise determined by the Spending Policy. In that case award distributions may nonetheless be made from gifts designated

as currently distributable by their donors up	p to the amount determined by the Spending Policy.
