## Part I: World Energy Investment Outlook by IEA

The lecture will present an explanation of the investment sums, accompanying risks, and policy issues surrounding energy demand in the next 30 years, in line with the *World Energy Investment Outlook* which is scheduled to be published this November. It will also make special mention of China and East Asia, where demand is expected to soar, and of the prospects for Russia and Australia, countries that are expected to supply increasingly large amounts of energy to the region, particularly gas. There will be a discussion of:

- 1) The amount of investments needed for the energy supply infrastructure
- 2) The risks arising from energy investments and financing
- 3) The role required of governments
- 4) Some energy investment scenarios
  - Oil investment in the Middle East is made only on a restricted basis.
  - The global warming policy currently under consideration by the OECD countries is actually introduced.

## Part II: Joint-Seminar of Eurasia Group and IEEJ <u>"New Oil Regime After the Iraqi War"</u>

We would like to discuss and exchange views about how the world oil regime will be developed after the Iraq war in the oil and gas sectors mainly in the Middle East as well as in Russia. There will be a discussion of:

- 1) US energy policy
- a national strategy
- security, stability, and diversification
- the US energy lobby and others
- 2) Some case studies
- Russia -- Murmansk, the Pacific Pipeline, and Transneft
- West Africa -- supporting development, ensuring stability
- Saudi -- the biggest problem on the horizon
- Iran -- US national security first, energy later
- Iraq -- a policy by inches
