# Obama Admin Allows Selling U.S. Citizenship to Babies Conceived Via IVF

# Planned Parenthood Blames Obamacare for Closing Clinic, Contraception Mandate Meant Fewer Customers

An ironic twist of fate has occurred, Planned Parenthood, which lobbied heavily for the Affordable Care Act, is now blaming the ObamaCare monstrosity for the closure of a Michigan clinic.

A local Michigan media outlet reports:

Planned Parenthood Mid and South Michigan is closing its Battle Creek clinic, citing "increasing competition and declining patient demand" as a result of the Affordable Care Act. The last day of operation will be Jan. 31.

Spokeswoman Desiree Cooper said the need for Planned Parenthood's health-care services has declined because of the ACA, which has greatly improved access to subsidized contraceptives and women's health-care services.

The ACA requires insurance plans to provide women with an annual physical and contraceptives without a deductible or co-pay. That means women who formerly were reliant on Planned Parenthood for services and birth control can now obtain them elsewhere, Cooper said.

President Obama once promised Planned Parenthood that abortion would be at the heart of his health care bill, and he kept that promise! —*LifeNews.com, January* 13, 2015

# Legislative Update

#### **House Passes Bill to** Completely Ban Taxpayer **Funding of Abortions**

The House approved legislation on January 22 that will put in place a complete ban on taxpayer funding of abortions that ensures abortions are not directly funded in any federal governmental program or department.

The legislation combines several policies that must be enacted every year in Congressional battles and puts them into law where they will not be in jeopardy of being overturned every time Congress changes hands from pro-life lawmakers to those who support abortions.

The House voted 242-179 for the bill with 239 Republicans and three Democrats voting to ban taxpayer funding of abortions under HR7 while 178 Democrats and one Republican voted against it. Congressman Tom Price said during the debate:

"This legislation prohibits taxpayer funding of elective abortions, no matter where in the federal system that might occur. This is a position supported by the majority of Americans in a bipartisan manner. We have

responsibility, through our government, to protect the most vulnerable among us, not the least of whom are the unborn. This bill is an important step in the right direction."

A majority of Americans object to the use of taxpayer money for funding abortion, according to numerous polls-including a survey CNN conducted in early April

showing Americans oppose public funding of abortion by a margin of 61% to 35%.

The bill will also mitigate concerns about abortion funding in the various loopholes in the Obamacare national health care bill that various pro-life organizations warned about during debate on the law. The legislation did not contain language banning funding of abortions in its provisions and the No Taxpayer Funding for Abortion Act would fix that problem.

The National Right to Life Committee sent a letter to House members urging support for the legislation that explains how the bill will help.

In September, 2014, the Government Accountability Office (GAO) issued a report that confirmed that elective abortion coverage is widespread in federally subsidized plans on the Obamacare exchanges. In the 27 states (plus D.C.) that did not have laws in effect that restrict abortion coverage, over one thousand exchange plans covered abortion, the report found.

H.R. 7 would codify the principles of the Hyde Amendment on a



permanent, government-wide basis, with respect both to longstanding federal health programs (Medicaid, SCHIP, FEHB, etc.) and to the new programs created by the Obamacare law. Under H.R. 7, for plan years beginning after December 31, 2015, exchange-participating health plans that cover abortion would not be eligible for the federal subsidies. Until then, the bill will revise Obamacare language to eliminate secrecy about abortion coverage, allowing consumers to be fully informed about abortion coverage and the surcharges for such coverage on plans sold on the exchanges.

A Member's vote on H.R. 7 will essentially define his or her position, for or against federal funding of abortion, for the foreseeable future.

Pro-life groups including Americans United for Life, the Susan B. Anthony List, Liberty Counsel and Family Research Council also support the legislation.

# Pro-Life Leaders Not Giving Up On 20-Week Abortion Ban By Steven Ertelt

op pro-life members of Congress and leading pro-life organizations are united in the face of opposition from some pro-life Republican members of Congress to the Pain-Capable Unborn Child Protection Act. They are vowing to not give up on unborn babies and promise the bill will eventually get a vote in the House and Senate.

A handful of pro-life Republicans sabotaged the bill on January 22 because they were unhappy with the language in the bill concerning women who are victimized by rape. But pro-life Senator Lindsey Graham, who is the prime Senate sponsor, says the bill will come back soon even though Republican leaders were forced to delay the vote.

Graham has introduced the Senate companion to that legislation, and conceded he did not recognize there was a problem.



"I can't wait for the debate. I'm looking forward to the debate. I want to hear how we're a better country by aborting babies at 20 weeks," said Graham, who indicated that as he envisions it, his bill would come as part of a broader debate on related issues, in what could prove a real test of the willingness of senators to take difficult votes.

National Right to Life President Carol Tobias told LifeNews.com, "The House of Representatives did not pass the Pain-Capable Unborn Child Protection Act this week because certain lawmakers who voted for the same language in 2013, and who had promised their pro-life constituents that they would do so again, instead worked to weaken the bill or to prevent it from coming to the floor."

"While we are profoundly disappointed that the vote on the bill was delayed, we much prefer delaying the vote to passing a greatly weakened bill," Tobias said. "We thank the House Republican leadership for quickly facilitating passage of the No Taxpayer Funding for Abortion Act (H.R. 7) which is another National Right to Life legislative priority."

"Pro-life citizens across the nation are sharply disappointed with those lawmakers who violated commitments to constituents and derailed a bill to protect babies in the sixth month and later, a bill with broad popular support," Tobias said. "In some cases these actions were apparently dictated mainly by inordinate concern with political correctness

and garnering favorable coverage from the mainstream news media. Some of these lawmakers may ultimately conclude that they were ill advised to sacrifice the trust of their pro-life constituents so egregiously."

Tobias complained that Rep. Renee Ellmers (R-N.C.) played the most visible public role in the successful campaign to stymie action on the Pain-Capable Unborn Child Protection Act—even though she voted to pass exactly the same bill language on June 18, 2013.

On January 20, Ellmers personally went to the House floor to withdraw her cosponsorship of the bill. Yet on January 22, she told *The Weekly Standard* that she would vote to pass the bill with or without language that she preferred, noting, "I have a very pro-life district..."

"We're going to bring this bill back. This is a fight that's not over. We're going to continue working to get this bill passed," House Majority Whip Steve Scalise (R-La.) told The Hill on Thursday.

Separately, Rep. Trent Franks (R-Ariz.), one of the sponsors of the pulled bill, said leadership gave him a "word of honor" the measure will get floor action.

Rep. Jackie Walorski (R-Ind.) also withdrew her cosponsorship on January 20, yet continued to affirm to constituents that she would vote to pass the bill (as she had in 2013).

- o A girl's troop keeps an average of just 10 to 20 percent of the money she collects from selling cookies.
- The local council receives an average of 65 to 75 percent of the money collected by all local troops.
- Girl Scouts USA (GSUSA) collects a royalty payment based upon their licensed trademark on every box of cookies produced. With approximately 200 million boxes of cookies sold annually, this amounts to millions of dollars of funding for GSUSA every year.

- Girl Scouts' curriculum for girls, sold and promoted by every local Girl Scout council, recommends pro-abortion role models/organizations such as Betty Friedan, Gloria Steinem, Geraldine Ferraro, Hillary Clinton, Amnesty Intl., Population Council, ACLU, and National Organization For Women.
- Local Girl Scout councils and GSUSA honor and promote abortion rights advocates and pro-abortion politicians including Nancy Pelosi, Kathleen Sebelius, Wendy Davis, and Elizabeth Warren among many others.
- Local Girl Scout councils and GSUSA connect girls to resources promoting abortion rights and inappropriate sexual content via official Girl Scout social media accounts.
- GSUSA is the largest member organization of the World Association of Girl Guides and Girl Scouts (WAGGGS), providing 2.8 million of its 10 million girl and adult members worldwide and paying approximately 1.5 million dollars annually to WAGGGS based on the number of registered GSUSA members.
- WAGGGS, which states that "anyone who is a Girl Guide or Girl Scout is automatically a member of the World Association of Girl Guides and Girl Scouts," aggressively promotes youth reproductive/abortion and sexual rights, specifically on behalf of its 10 million members.
- O GSUSA maintains memberships in additional abortion advocacy groups, including the Coalition for Adolescent Girls and Re:Gender. Other organizations working alongside GSUSA in these groups include abortion providers International Planned Parenthood Federation and Marie Stopes International, and numerous organizations that push for unrestricted abortion rights, such as the Feminist Majority Foundation and the National Women's Law Center.



#### Is There Hypocrisy About Which Black Lives Matter?

Recent events across the country have increased racial tensions. It has caused many to declare that "Black Lives Matter" because there is a perception that blacks are unfairly targeted. This alleged unfair targeting is blamed for the death of many of those in the black community. But the focus of the protests that have sprung up around the country only take into account those who have already been born. The crisis of abortion in the black community is all but ignored.

The unfortunate fact is that when looking at the abortion issue, we don't see this same outrage. If those protesting would take a broader view, they would realize that what they are protesting pales in comparison to the genocide that is happening through abortion. According to the Michigan Department of Community Health, if you look at the number of abortions in 2013 in Detroit alone versus the remainder of Wayne County, Detroit had nearly twice the number of abortions at 6,530 as opposed to 3,923. Then comparing this to Macomb and Oakland, these counties had 2,567 and 3,347 abortions, respectively.

This gives local abortion rates of 15.8% for Macomb, 14.3% for Oakland, 18.7% for Wayne County excluding Detroit, and 32.3% for the city of Detroit.<sup>3</sup>

This clearly shows that urban areas are targeted by the abortion industry. In addition, if you compare Hispanic abortions versus black abortions for the state, there were 838 abortions of babies with Hispanic ancestry as opposed to 12,729 abortions of blacks.<sup>4</sup>

This is the much told but unheard dirty secret of the abortion industry. Urban, poor neighborhoods are targeted by the abortion industry because the central planners of the world see the poor as less than human. But these numbers tell an even darker secret. Blacks are specifically targeted by the abortion industry. The statistics broken down by county published by the state do not also break down abortions by race. Statistics by race are only published for the entire state. However, with blacks having a 15.2 to 1 abortion rate higher than Hispanics within the state, it can be deduced that a larger percentage of the 6,530 abortions in Detroit are black. This can be further solidified by the 2010 U.S. Census numbers showing 82.7% of Detroit's population is black, 6.8% is Hispanic, and 7.8% is white.<sup>5</sup>

The Radiance Foundation regularly puts out statistics that show how abortion is the number one killer in the black community. An even more shocking fact is that, in New York City, more abortions are now performed than live births of blacks. Detroit is not that far behind. The Michigan Department of Community Health's statistics of live births of blacks in Detroit versus abortions in 2012 were 8,326 births and 5,307 abortions.<sup>6</sup>

#### Roe v. Wade Has Not Settled Abortion Debate

It has been 42 years since the U.S. Supreme Court ruled on the issue of abortion in the well-known case *Roe v. Wade.*Abortion advocates claim that *Roe* is settled case law, but after more than four decades, abortion remains one of the most contentious issues in our society.

Why? If abortion is simply a medical procedure to remove a blob of tissue, it should not be controversial. If abortion is just a medical procedure, why do many people characterize it as a difficult decision, a "necessary evil"?

Most Americans are troubled by abortion because they recognize that abortion is something much more than a medical procedure. Abortion destroys a human life.

That the unborn is a human life is becoming more apparent than ever before. New 4D ultrasounds show amazing details of the life growing in a mother's womb. Ultrasounds show preborn babies smiling, turning somersaults, or sucking their thumbs. New research is pointing to the capacity of preborn babies to learn in utero. One study from the University of Florida found that babies begin to learn nursery rhymes in the womb.

If *Roe v. Wade* has settled abortion law, why are so many women speaking out about how abortion hurt their lives? Through the Silent No More Awareness Campaign, thousands of courageous women speak out about their abortions and share their regrets, grief, and healing. They speak because they want other women to know that there always is something better than abortion for them and their babies.

If *Roe v. Wade* is settled, why are millions of young adults flocking to the pro-life cause? Young adults in high schools, colleges and communities all across the U.S. are working to provide life-affirming support for pregnant and parenting women and their families. Pro-life student clubs outnumber pro-choice clubs by more than two to one, according to Students for Life.

If *Roe v. Wade* is settled, why do Americans continue to elect pro-life legislators? In the past four years, state legislators passed 231 pro-life laws, according to the Guttmacher Institute. And in November, Americans elected even more pro-life leaders to our state and federal legislatures.

If *Roe v. Wade* is settled, why do most Americans oppose what *Roe* did? Four decades after *Roe*, a majority of Americans (58 percent) still believe abortion should be legal in only a few circumstances or not at all, according to a 2014 Gallup poll.

*Roe*, coupled with companion ruling *Doe v. Bolton*, opened the doors to abortion on demand essentially through all nine months of pregnancy in 1973. *Roe* created a no-limits abortion scene: no parental consent requirement for minors, no requirement to provide women with basic information about abortion risks and alternatives prior to the procedure, no medical regulations or accountability standards for abortion centers, no restrictions on abortions after the baby is viable.

Thankfully, in the past 42 years, pro-lifers have worked to enact many of these common-sense regulations – measures that most Americans approve.

Roe v. Wade was a radical decision that opened the doors to the legal destruction of 57 million preborn babies. Now more than ever, it is clear that Roe v. Wade was bad case law. There are better solutions to our problems than killing the smallest and most vulnerable among us. —Micaiah Bilger is Education Director of Pennsylvania Pro-Life Federation, Harrisburg

It is time to take our country, our churches, our press and our educational system back. We can do this through love and respect of all human life and living out that belief through our own actions. It is about creating strong families and institutions that promote a respect for all human life. How do we do this? We do this by doing what we have done for the past 45 years—never give up, continue to educate and promote life values within our individual circles of family and friends and pray. Do not get discouraged! When you see all the young people in Washington, DC, you know that they will one day change this country and bring back legal protection to all life, especially in the womb.

The only media that covered the entire March from start to finish was EWTN—kudos to them.

I would like to thank Lynn Gura for her dedication and excellent work in organizing the nine buses that went to the March. I thank also the 74 bus captains and chaperones who enabled us to do this project. Keeping track of 364 young people is not an easy task. May God bless all of you for your continued commitment to the cause of LIFE.


