Cross-Border Family Mediation Training (CBFM) Sunday, 2nd October – Saturday, 8th October 2016

This 50-hour advanced training course aims to qualify practising family mediators to mediate crossborder family disputes, including international child abduction, access and custody cases. The course will cover the relevant legal aspects of international family conflicts, differences in national family legislation, the 1980 and 1996 Hague Conventions, the Brussels II *bis* Regulation as well as the best interest and the voice of the child. Participants will be introduced to tools and methodologies for mediating high conflict cases. Case studies and role plays will be an integral part of the course. Drawing on the participants' experience, we will examine the issues of mediating across cultures. Interdisciplinary cooperation is a key aspect of the course.

We look forward to working with legal, psycho-social, educational and other professionals from a variety of cultural backgrounds and nationalities.

A maximum of 25 participants will be accepted for the course.

MiKK is an internationally recognized NGO that has been working for over 10 years to promote and organize mediations relating to international family conflict. The concept employed in MiKK's training was developed and piloted in the EU Civil Justice project "Training in International Family Mediation 2010 – 2012". MiKK trainers have conducted similar seminars in many countries including Australia, Belgium, Germany, Japan, Kosovo and Russia. Participants who complete this training course may join the MiKK pool of mediators and the Cross-Border Family Mediators Network.


