PLEASE BE ADVISED THAT THE FOLLOWING CHANGES ARE APPLICABLE TO THE ORIGINAL SPECIFICATIONS OF THE ABOVE REFERENCED ITB.

- Clarification: Awarded contractor will warrant that areas planted with sea oats and railroad vine shall display EIGHTY PERCENT (80%) survival at the end of ONE YEAR from the date of final installation.
- Corrected Bid Schedule attached
- Clarification: The area to be planted is approximately 3200 sf
- Please see that a revised Sheet P1 is attached showing elevations and location of stairs
- Article 1 (Scope of Work), paragraph O being modified to require Contractor to rake the sand at the end of each day during turtle nesting season to remove vehicle tracks. See Attached paragraph.
- The sand/fill that is excavated for the installation of the 36" ADS pipe will be suitable for fill landward of the crest of the proposed dune construction or between station 1+60 and 2+00.
- "Moisture Shield" will be a suitable replacement for both decking and handrail top cap.
- Pile embedment for the pile-constructed boardwalk section will be based on the existing grade.

O. County will provide limited rights of way and easements necessary for equipment access to the beach in the areas where work is to be performed by Contractor under this Contract. The Contractor shall be required to document via videotape the condition of all access locations and rights of way prior to initiating any construction activity. A copy of the videotape shall be provided to the County. The Contractor shall be responsible for any repairs required to restore equipment access locations utilized during the work, including but not necessarily limited to paving, fencing, boardwalks, dunes and vegetation. During turtle nesting season (May 1 through October 31) Contractor shall, at the end of each work day, rake the sand around the work site to eliminate tracks caused by Contractor's vehicles.
