Brief support enquiries

Our service offers short-answer technical support to practitioners seeking clarification or guidance on matters that can be dealt with in a brief manner (5 to 10 minutes), at no charge. The number of allowable member enquiries is not capped and we endeavour to respond to members' technical queries within 24 hours.

Any employee of a member firm may use the service, simply confirming their own name, their firm's name and membership of BDO's PPN.
