AACE Certification Update

CCC/CCE and CCT Certifications Achieve Maximum Term of Re-Accreditation with CESB

AACE International is pleased to announce the **Council of Engineering and Scientific Specialty Boards** (CESB) re-accredited AACE International's Certified Cost Consultant (CCC), Certified Cost Engineer (CCE) and Certified Cost Technician (CCT) certifications at its recent 2012 Annual Meeting, for the maximum term of five years; each certification is accredited until December 31, 2016.

Valerie Venters, Chair of AACE International Certification Board, stated, "On behalf of the Certification Board, we are pleased to receive, for the first time since accreditation, the maximum accreditation period of five years with no mandatory actions required. The recent decision of the CESB Board is recognition of our efforts to ensure the quality and integrity of our certification program."

AACE International's Planning and Scheduling Professional (PSP) and Earned Value Professional (EVP) certifications are also accredited by CESB, expiring December 31, 2014. It is the intention of the Certification Board to submit an accreditation application for its Certified Estimating Professional (CEP) certification by December 31, 2012.

Accreditation involves a detailed evaluation of all aspects of a certification program's operations to determine compliance with CESB's Accreditation Guidelines.

CESB is an independent, voluntary membership body created for its member organizations who recognize, through specialty certification, the expertise of individuals practicing in engineering and related fields created in 1990. As an accrediting body, CESB provides basic criteria and guidelines for certification programs for engineers, technologists, technicians, and related scientific specialties. CESB's Accreditation Guidelines and other information are available at www.cesb.org.

2011 Certification Progress Report

In keeping with our accreditation guidelines of the Council of Engineering and Scientific Specialty Boards (CESB), the Certification Board of AACE International announces the 2011 Annual Certification Progress Report is now available and published on our website for review here. (The AACEI Web Site) To summarize, the report reveals a 21% increase in 2011 active certifications, compared to 2010, with a grand total of 3,717 certified individuals.

The Certification Board is also pleased to report the results of the **Amnesty Program**, whereby previously expired certified individuals were given an opportunity to regain their credentials until December 31, 2011. Under the program, 90 applications have been received; 80 have successfully regained their credentials to date, while several applications are still pending due to documentation currently being evaluated.

Highlights from the March 22d Meeting

The March Dinner Meeting was highlighted by our guest speaker, Mr. John Lopez, who is the Acting Deputy Director of the Savannah River Recovery Act Project. This project was undertaken as part of the American Recovery and Reinvestment Act (ARRA) at the Department of Energy's Savannah River Site and focused on three key objectives. These objectives were (1) the reduction of the site's active footprint, (2) the disposition of legacy Transuranic (TRU) waste, and (3) the investment in the purchase of new equipment or upgrades to existing equipment related to the site's Liquid Waste Program.

The reduction of the site's active footprint was the main objective of the project and involved targeting several areas that were no longer engaged in active nuclear operations and accelerating the closure of these areas. This footprint reduction mission included performing the necessary environmental remediation activities and disposition of the former nuclear facilities. Significant accomplishments included the insitu decommissioning of P Area Reactor and R Area Reactor, the complete decommissioning of the Heavy Water Components Test Reactor (HWCTR), and the remediation of the P and R Area Ash Basins.
