**Revised Process for Renewal of Registration Cards**

Dear Applicant

FÁS has introduced a new process for the Renewal of CSCS/QSCS Registration Cards.

Where a persons CSCS/QSCS Card is due for renewal they will be required to submit an Application for Renewal including confirmation of Work Experience during the **previous five year period**, i.e. the five year period prior to the Expiry Date on their existing Operator's Card.

1. Complete the Renewal Application Form and attach one Passport Size Photograph, which should be signed on the reverse side.
2. Enclose either Euro (€) cheque, bank draft or postal order for €23 made payable to *FAS CSCS*. **Please do not send cash.**
3. Return the form and payment to:-

FÁS will process your application and provided the details are in order, FÁS will issue you with a CSCS/QSCS Registration Card.
