Route and Finish Line

This 5K Run/Walk will start and finish at Helke Park in Vandalia located at 888 Randler Ave.

Day Of Event

Registration and check-in will begin at 7:00am at Helke Park. Participants will start at 9:00am. The course will be open for 2 hours.

Entry Fee

The entry fee is \$25 and includes a sweat-wicking technical t-shirt, a bottle of water, snacks, refreshments, and an entry to win a grand prize or a door prize.

Registration on the day of the race will be \$25 and will include a T-shirt (while they last), however it will not include an entry for the grand prize.

Refreshments

Each participant will each receive a bottle of water. Plenty of liquids and a variety healthy snacks will be available under the shelters at the completion of the race. Refreshments will be donated by local businesses and served by family, friends and student volunteers.

Course, Timing & Results

Our professionally certified 5K (3.1 mi) course is flat and offers runners a chance to push for their best 5K time. Electronic chip timing is provided for all participants. Mile splits will be provided during the race. Individual race results will be available immediately after you finish the race. Overall ranking and age group placement will be available 72 hours after the race. The course is also great for walkers, strollers and family participation is encouraged. Pets on leashes will be permitted. No bikes, skates or roller blades will be permitted.

Door prizes will be chosen at random by runner/walker bib number. All participants are eligible to win something. Only per-registrants will be eligible for men/women's grand prize and first tier door prizes. See the chart for age divisions. The top three runners in each division will receive a certificate of placement. The first male and female finishers will receive special prizes.
