ABC admits lie, NYPD Blue losing big bucks

Remember last fall when **NYPD Blue** went on the air? The TV critics gave it their highest acclaim. Sure the sexual nudity was there, but nothing more than one would see in a theater. Sure the extreme language was there, but nothing more than one would hear everyday in the workplace. Sure the violence is a little more than usual, but it is set in the context of the program.

In an effort to win advertising and give respectability to the program, ABC repeatedly told the media that all advertising times for **NYPD Blue** were sold at the full price of \$115,000 per 30 seconds. AFA stated at the time that ABC was not telling the truth, that all the time was not sold and the time that was sold was sold at a greatly discounted price. In other words, ABC was

lying to the public.

During the TV critics annual convention in Los Angeles in January, ABC president Robert Iger admitted to the critics that the network was losing money on the program because the network was not getting full price for ads. Additionally, it was learned that ABC was able to sell an average of five minutes of advertising time on **NYPD Blue**. Usually, in an hour program such as **NYPD Blue**, the network would sell seven minutes of time.

AFA has learned that many advertisers paid only 10¢ on the dollar for time on the program, or \$11,500 per thirty seconds. AFA estimates that ABC lost approximately \$17,000,000 of potential ad revenue the first 17 times the program ran.

Headlines in the January 11 edition of the Atlanta Journal/Atlanta Constitution told the story: "Latest 'NYPD' blues: Hit losing big money." The paper went on to report that "**NYPD Blue** may be a ratings and criti-

Kmart continues to sell pornography

■ Company takes \$1.3 billion write off and sets 800 stores for closing

Kmart Corporation recently announced that it will write off \$1.3 billion, or \$850 million after taxes, against its 1993 earnings. The company had announced earlier that it was closing 300 stores, but now says that it will be closing 800 stores.

Chairman Joseph Antonini said that earnings for 1993 would be substantially lower than the \$1.15 per share reported in the fourth quarter of 1992, and the \$2.06 per share earned for fiscal 1992.

In announcing the Kmart decline, news accounts did not report on the boycott of Kmart by AFA. The boycott is now three years old and the financial health of Kmart has consistently gone down since the boycott began.

Kmart is one of the leading retailers of pornography in America. The pornography is sold in Waldenbooks and Borders books stores, owned by Kmart. Kmart has the authority to order Waldenbooks to get out

of the pornography business at any time. All profits from the sale of pornography go to Kmart. AFA repeatedly has asked Kmart chairman Antonini to stop selling pornography in their Waldenbooks stores, but Antonini has arrogantly refused.

AFA does not credit all of the financial woes of Kmart to the

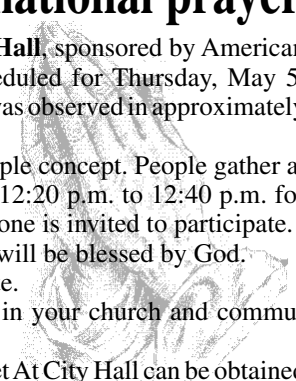
May 5 – a call for national prayer

When the church begins pagan worship, it is time to act

In last month's *AFA Journal*, we reported on the "Re-Imagining" conference held in Minneapolis November 4-7 last year. The title of the conference was "A Global Theological Conference By Women; for Women and Men." If you failed to read the article, I suggest you go back and read it. It can be found on page 14 of the February *AFA Journal*.

News of the pagan nature of the conference is now beginning to reach beyond the approximately 2000 participants in the conference. Grassroots members of the sponsoring groups in the various denominations are just now beginning to learn of the conference and react. The *Presbyterian Layman* reported that Rev. James Brown, executive director of the General Assembly Council of the Presbyterian Church USA, called in a Louisville public relations firm to help put the right "spin" on their response in dealing with the outcry.

United Methodist Bishop Earl G. Hunt of Lake Junaluska, North Carolina, said that deifying Sophia (which is what the conference did) is an "attempt to reconstitute the godhead. ...No comparable heresy has appeared in the church in the last 15 centuries. This material must be eradicated from Christian thinking now. When the church seems to be losing its struggle with powers and principalities, weird things begin to happen."

One of the disheartening things about the conference and those who participated in it is that, in the final analysis, money for the conference came from devote God-fearing Christians in churches who had no idea that their gifts would be used in such a manner.

I am convinced that as long as the Christians in local churches remain ignorant of and silent about situations such as happened in Minneapolis, their gifts will continue to be used in a similar way. Without strict guidelines limiting how the gifts can be used, one way to prevent such from happening again is for local church groups (women's groups, etc.) to withhold their donations to their denominational boards and agencies which supported the conference. I am sure that there are other worthy causes, more in line with the beliefs of the Christians in the local churches, to which those funds can be applied.

I hate to compare the two, but I have learned from the secular world that when funds begin to dry up, you can get some changes. Sometimes, that is the only way to bring about desired change.

At the time this column was written, not a single one of the denominational groups which funded and supported the "Re-Imagining" conference had repudiated the contents of the conference. Attending the conference were leaders from the Presbyterians USA (405), United Methodist (391), Lutherans (ELCA) (313), Roman Catholics (234), and United Church of Christ (144). Also participating were Baptists, Episcopalians, Mennonites, United Church of Canada and the Church of the Brethren.

Why mention the conference in the *AFA Journal*? Two reasons. What those in the highest level of our denominations do matters. And second, the *AFA Journal* goes to 175,000 churches and pastors – probably more than any other publication in America.

On my dad's office door is this cartoon. The caption reads: "Don't ever give up!"

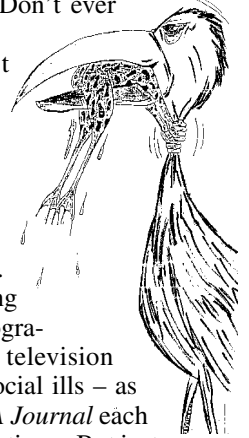

Publication highlights waste and fraud in nation's capital

A recent 24-page report from the National Taxpayers Union describes government waste and fraud in Congress. Here are some highlights from *Power, Perks and Politicians*. - Our Congress has more millionaires than any other elected government body in the world.

- Two years ago Congress voted its membership a pay raise to \$125,000 per year (top 2% income bracket in the nation) with an "automatic escalator." The salary has now risen to \$133,600.

- Senator John Glenn stiffed many small businesses with his \$3.8 million campaign debt. He now lives in a \$1.2 million mansion outside Washington.

- A staggering number of Congressmen – plus President Clinton – send their own children to elite private schools.

- For years, Congressman Mel Reynolds of Illinois failed to pay back the \$14,704 in government-backed student loans he took out to go to law school.

- 231 House members and 72 Senators could collect more than \$1 million each in pension funds after 1993.

- For about 50 years, Congressmen didn't have to pay FICA deductions or social security taxes. This changed in 1983.

- Over the last 10 years, 250 of the largest medical industry Political Action Committees (PACs) have donated \$45.3 million to members of Congress. Of that, more than one third – \$18.6 million – went to current members of the four most important health care committees in Congress.

- Since the Congressional elections in 1992, PAC's have contributed \$565,730 to campaign committees of freshman members of Congress.

- Total amount the government spent on food stamps in 1979: \$550 million; total amount spent in 1990: \$14 billion.

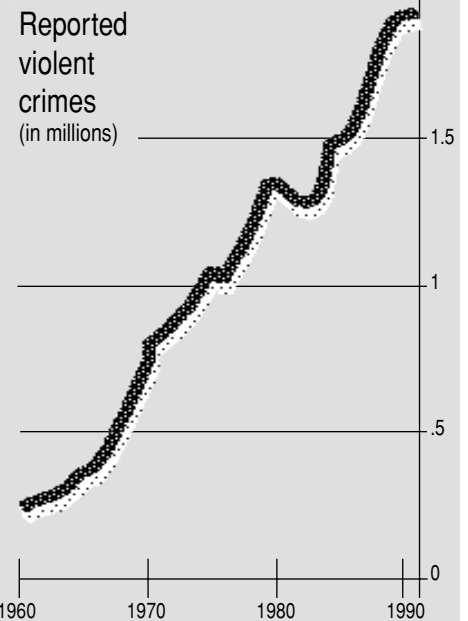
- Government expenditure, per student, for public education in 1970: \$1,247; in 1990: \$6,575.

- Average change in combined national SAT test scores between 1970 and 1990: down 49 points.

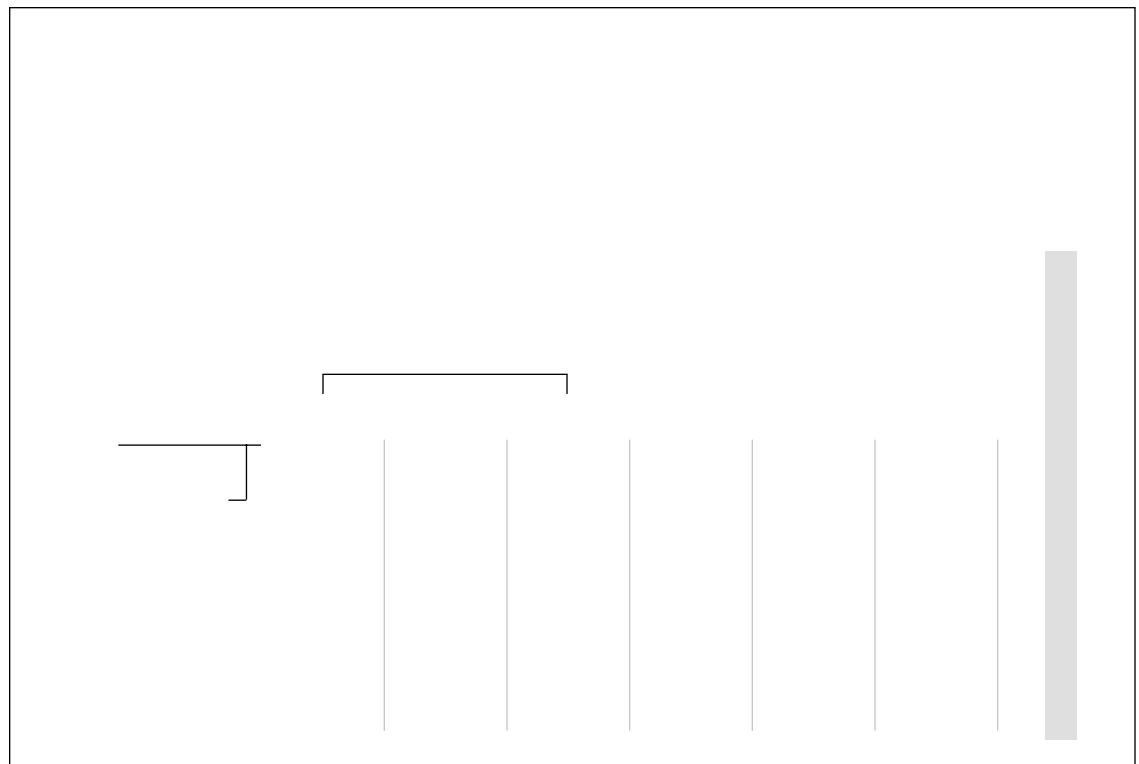
- Washington, D.C. and suburbs rank first among U.S. cities in: total number of citizens employed by the government; total number of imported auto sales; total number of high income families.

The first nationwide survey of HIV infection shows that between 300,000 and 1,000,000 Americans are HIV positive – considerably lower than previous government estimates. The survey by the National Center for Health Statistics found that only 29 of 7,992 (0.36%) Americans sampled were HIV positive.

In addition, statistics from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention show that 90% of all full-blown AIDS cases are people who practiced intravenous drug use and/or homosexual behavior.

*Time to tune out TV programming***Television is a toxic dump and the President should clean it up**

Is there a massive pileup dead ahead on the information highway? Call the wreckers. Cue the EMTs. We're getting into 500-channels-and-there's-nothing-on territory.

Too much of TV is getting so bad, who wants to watch it any more? With every media megapoly buying any chunk of Tubeland it can, the market resembles a gold rush. What if there's only low grade ore to be mined?

I'm talking about programming. Programming can be as good as human inventiveness can make it. Or as bad. And the bad drives out the good in TV territory. And at the end of the day, dross prevails. When the bean-counters sit down with the numbers and see how consistently quality is overwhelmed by titillation, the TV biz slides downmarket another notch.

And another, and another. How many notches will be left before we are totally below the belt in prime time? Look at this dreadful stuff they put on TV. It reeks. And each successive generation of TV execs is younger, crasser, coarser and even more vulgar than the 29-year-old he or she replaced.

TV has become the landfill-of-choice for popular culture. And you let your kids watch this stuff? Are you sick?

As bad as they can be, movies in theaters do not invade your home through the TV set. But TV programming has mimicked the worst of video culture: sex, violence, sickness, immorality, indifference to suffering and even depravity. Let's call a sick puppy a sick puppy. TV, which used to be Newton Minow's wasteland, is now a toxic dump. It's bad for people, especially children.

So what's new? Everyone with any brains already knows this. I'll tell you what's new. What's freshly frightening is the amount of money being poured into the finite limits of the TV market.

Large debts are taken out in the gamble that X million viewers can be persuaded—or seduced—into watching channel 499 or 387. And if the proprietors don't get their X million, they'll start flashing their X rating.

The huge sums involved dictate increasingly desperate tactics. Trash begets more trash. People of intelligence, wit and worldly experience—who realize how brutalizing this fare is on children—effectively withdraw from the market. They lock up their

TVs or destroy them. Their kids find other things to do. The kids who turn into TV zombies are tracked into lowest common-denominator schooling.

It becomes a vicious cycle.

Does it have to be? Of course not. Here are three tools: political pressure, consumer pressure and advertiser pressure.

President Clinton flew to Hollywood, met his show-biz pals and backers, and told them off. Hollywood prides itself on being just a bit more immoral than the rest of America. And it will—until it actually begins to pay to clean up its act. Violence and sex still sell, despite Clinton's sermonizing. Which brings us to consumer pressure.

Consumer pressure works. Ask the nation's biggest retailer. Wal-Mart will no longer sell handguns in its stores. So the good news is that there are 2000 fewer stores where handguns can be purchased. The bad news is that still leaves 283,000 other retail outlets for handguns. And why did the place where America shops dump the handgun-on-display? Customer anxiety.

"They don't want to be around them," a Wal-Mart spokesman told The New York Times. OK. That's a start. The gun got fired by Wal-Mart. Which brings us to Step 3: advertiser pressure.


Charles Ferris—a former chairman of the Federal Communications Commission, now a lawyer in Washington—favors what he calls "sort of the vigilante approach." He believes in pressuring advertisers to pull sponsorship from programs that a large swath of the audience finds objectionable.

Use the market mechanism, he counsels. "Look at who's trying to sell product. Who's sponsoring it? People selling beer or Chevrolets don't like controversy. They don't want to alienate people; they want to make friends."

A successful Boston computer tycoon who helped raise \$850,000 for the Clinton-Gore campaign is applauding Clinton's get-tough message to Hollywood.

"As with guns," says John Cullinane, "America is losing its patience with the obsession with sex and violence in all aspects of the communications business, including news programs."

He once bought a \$500,000 30-second spot during a Super Bowl. He knows. He wants Clinton to summon America's top CEOs to Washington, make them sit through some of the programming they sponsor and call them on the carpet, then and there.

"Effectively addressing the sex and violence issue in our electronic media would be the single most positive thing President Clinton could do in his administration." 

*A little good TV news***Catherine Marshall's 'Christy' scheduled on**

Producer Ken Wales has spent almost 20 years—and a lot of prayer—on his dream to bring one of this century's premier Christian novels to the screen. "I first dreamed of bringing Catherine Marshall's novel **Christy** to the screen nearly 20 years ago," says Wales. "At the time there was no way I could have imagined how long and how difficult a struggle it would be."

Christy is based on Leonora Wood, Catherine Marshall's mother, and her experiences as a young, struggling teacher in 1912 amid the poverty of the Great Smoky Mountains.

Wales learned in 1976 that MGM owned rights to the book. When he called MGM to inquire about it, he was told that **Christy** had been bought and put into development in 1969, but was shelved when a new studio head took over. Wales joined forces with Marshall and for a few years the two of them attempted, with no success, to buy back the rights.

He thought his dream died in the mid '80s, for Catherine Marshall died in 1983, and her mother a few years later.

In 1993, however, CBS expressed interest in **Christy** as a series. Wales first said he wasn't interested, for he had envisioned **Christy** on the big screen. But, he says, "The more I prayed about it, it seemed that God was telling me that letting the story unfold in a television series would give us a better chance to explore the characters and their lives by bringing them into the homes of millions of people every week."

Filming began last September in the Tennessee Smokies where Leonora Wood had taught some 80 years earlier. At press time, **Christy** was scheduled to debut in March.

AT&T, Unilever, Warner-Lambert support violent television movies

The prime-time parade of violence marched through all four networks with graphic gore in numerous January movies carrying viewer discretion advisories. A sampling of such family-time features includes the following.

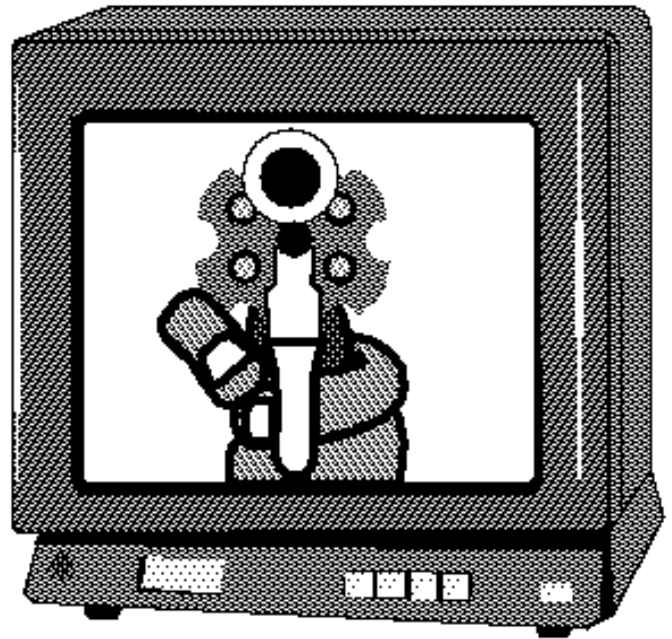
■ CBS aired **Armed and Innocent** on January 4. It was the story of the Holland family and their problems after 11-year-old Chris Holland shot a robber to death. At home alone one afternoon, Chris is frightened by three men who knock at the door, then a short while later return to break into the home. He confronts the robbers with a rifle, drilling two of them full of bullets, while the third gets away. One bloody body lies in the yard and the second is in the car. William Beaudine, Jr., produced the Danielle Hill script. **Advertisers: AT&T, Unilever, Warner-Lambert**

■ **Tango and Cash** aired on ABC January 9, with its literally countless number of gunblasts and barrage of profanity. The teaser has two men crashing through a truck windshield onto the pavement, one auto crash and one explosion. Car crashes occur throughout the movie until one loses count, and at least 15 explosions occur. One prison scene features the two heroes (innocent inmates) being tortured by other inmates who hang the heroes on steel cables, then lower their feet and legs into electrically charged vats of water. In addition, sexual double entendre occurs. Randy Feldman wrote the story; Jon Peters and Peter Guber produced. **Advertisers: Unilever, Warner-Lambert**

■ NBC featured **Murder Between Friends** on January 10. The movie tells the story of best friends Bill and Kerry whose plot to murder their two wives goes awry; the two men are featured in a bloody scene, one stabbing the other with a knife and one beating his friend with a baseball bat. The scene is graphically portrayed, and is re-played a number of times. Philip Rosenberg scripted the David S. Hamburger production. **Advertisers: AT&T, Unilever, Warner-Lambert**

■ **Dark Reflection** was the Fox network's January 10 contribution in which Ben discovers that he is one of six experimental clones. Alex, another of the six, is systematically doing away with the others, usually driving them to suicide. When Ben discovers Alex's plan, Alex leaves him tied up to die of carbon monoxide poisoning. Ben escapes, and the movie climaxes in a scene in which Alex crashes Ben to his death, then assumes Ben's identity as husband and father. Todd Slavkin and Darren Swimmer wrote the bizarre script which was produced by Kevin Reidy and Bob Lemchen. **Advertisers: AT&T, Warner-Lambert**

■ On January 2, NBC debuted **Viper**, a futuristic tale of a super-auto developed for use by a major city police force. Though NBC offered no parental or violence advisory, the movie boasted fiery explosions and gunfire. The movie was also quite politically correct. Unethical lawmen "stole" Michael Peyton's memory with drug treatment; in so doing, they were "rehabilitating" a criminal



and producing a driver for their super crime-fighting machine. Another scene featured a passionate anti-gun speech delivered by a hero in a wheelchair (yes, put there by a bullet). Series creators Danny Bilson and Paul DeMeo wrote the initial script; producers were David L. Beanes and Michael Lacoce. **Advertisers: AT&T, Unilever**

■ **Terror in the Night** came to CBS on January 11. In this one, maniacal killer Lonnie stalks Tom and Robin, lovers camping in a national forest. Lonnie rapes Robin and leaves Tom for dead. Tom, however, survives and escapes the ropes with which Lonnie had tied him. Lonnie rapes Robin again. Traveling with Lonnie are his lover Tina and her two children. **Advertisers: Unilever, Warner-Lambert**

Homosexual agenda is networks' agenda

Numerous prime-time series continue to propagate the politically correct stance on the "normalcy" of homosexuality. As the networks and advertisers persist in promoting the homosexual agenda, they are subtly changing from dealing with homosexuality as an "issue" of debate to the pretense that homosexuality is accepted by all as the equivalent of a normal lifestyle.

■ ABC's December 21 episode of **Roseanne** (a repeat) brought back Roseanne's former boss Leon, a homosexual with a recurring role in the sitcom. Roseanne's bisexual friend Nancy also figured prominently in the

story. Having been disappointed by a lesbian date, Nancy whined, "...I'm back into men this week."

Advertiser: Clairol

■ On the Fox network's **Melrose Place**, homosexual character Matt, a regular in the ensemble cast, appeared in the January 6 episode. Matt was prominent in one scene encouraging Michael, paralyzed from an auto accident, in his physical therapy session. The heterosexual bed-hopping of the remainder of the cast rounds out the rest of the hour. On January 12, the characters continue their penchant for lies and deceit, e.g.,

Billy encourages Alison (his live-in lover) to avenge herself against Amanda (her boss, Billy's ex-lover) by sabotaging Amanda's accounts at work while she is away. "The only rule in business," declares Billy, "is there are no rules." In the same episode, Michael gets Sydney (his ex-lover, his ex-wife Jane's sister) to hire a prostitute to seduce Robert (Jane's lover) so Michael can tape the rendezvous to win Jane back from Robert. Chip Hayes produced both episodes; Darren Star wrote the first, Frank South the second. Profanity and vulgar name-calling is standard fare in dialogue.

■ CBS features Ron and Eric, a homosexual couple, in their **North-ern Exposure** series. In the January 10 episode, Maurice meets them on the sidewalk and delivers concert tickets he'd gotten for them. They offer Maurice a ride to Anchorage, but he declines because it might imply that he validates their lifestyle. Later in the episode – after another character explains that *all* sexual behavior is normal – Maurice apologizes to the homosexuals for his "homophobic" behavior. Diane Frolov and Andrew Schneider wrote the story; along with David Chase, they are also producers.

■ **Birdland** debuted on ABC January 5. The hour-long drama was written by Walter F. Parkes and Scott Frank; Frank and Laurie MacDonald were producers. The dead end on non-judgmentalism

In value-free America, non-judgmentalism has reached its dead end. Not only are we not allowed to pass judgment on people, we can't even characterize animals.

In Hooksett, New Hampshire, on Christmas Day, an Alaskan malamute dog named Sasquatch killed a 5-year-old boy. Commenting on the tragedy, Christopher Agrafiotis, the town's animal control officer, observed: "We don't know that (Sasquatch) is a vicious animal. But ... that was a vicious act."

If the context weren't so horrible, the remark would be hilarious. We wouldn't want to stigmatize the poor pooch. We don't know what led him to this desperate act. Sasquatch could have been an abused pup, the product of a dysfunctional kennel. Was his crime a bark for help? You know the routine.

If there's one thing we're good at in America today, it's not assigning blame. Over our public policy debate should be posted a sign reading "Excuses R Us."

In mid-December, a study disclosed that 83% of students at the Massachusetts Institute of Technology cheated at least once on a homework assignment or test during the 1991-92 school year.

Norma McGavern, director of undergraduate research at MIT, observed: "Of course it's worrisome, but we're not looking at this in a *moralistic* way, to say people who do this are bad and they're beyond helping."

If not "bad," what would you call them—honorable, trustworthy, paragons of virtue? Little wonder that such high percentages of college kids are admitted cheats, when our culture can't bring itself to unequivocally condemn conduct that's clearly wrong.

Whatever you did, there's a justification. The search for exculpating circumstances is a never-ending quest. Absurd lengths aren't a bit too far to go to rationalize the inexcusable.

Discussion of the AIDS crisis is brimming with blame avoidance. Those infected are all victims activists insist. AIDS isn't caused by homosexual promiscuity, it's caused by a virus, a spokesman for the gay community disingenuously declared. Don't ask how the virus is *spread*.

In New York City, Patti Davis (daughter of Ronald and Nancy Reagan) — the ultimate I'm-OK gal — is conducting seminars on how to successfully blame your family for messing up your life.

We've sanitized our language to facilitate blame avoidance. Instead of fornicators, we

speak of *cohabiting couples*. *Addicts* (junkies) have become *drug abusers*. Criminals are *offenders*, as if they had merely transgressed the bounds of etiquette. Or how about the homeless — formerly bums, winos or vagrants. The new term is nicely neutral, implying that all denizens of the streets are bereft of habitation by an act of God, certainly through no fault of their own.

Needless to say, no one is guilty of anything. Separate California juries are pondering the fate of Lyle and Erik Menendez, the Beverly Hills brothers who blew away their mother and father in a volley of shotgun blasts, for a \$14 million family fortune.

What should have been an open-and-shut case turned into a five-month, three-ring circus. Erik and Lyle, alleged victims of childhood sexual abuse, murdered their parents out of fear their folks were plotting to do them in, their wily attorney (playing to the temper of the times) argued.

Poor Lyle was so traumatized by years of abuse that after massacring Mom and Pop, he spent \$15,000 on Rolex watches and \$70,000 on a Porsche. It's amazing what an expensive

sports car can do to salve a psychic wound.

Liberal dogma and the therapy culture have combined to foster our current aversion to assigning blame and taking responsibility; the two go hand in hand. Why, heavens to Freud, finger pointing might give someone a complex. Above all, we want people to feel good about themselves, whether or not that sentiment is warranted. Besides, we know it's all environmental or genetic or societal or political or anything but volitional.

Ask not why there are 23,000 murders a year in this country, why the most horrific crimes imaginable daily assault us from the news pages. Poverty, injustice, guns? During the Depression there were more of each, and the crime rate actually declined. What they had, which we are rapidly losing, is a sense of shame. Moral issues then were black and white and not soothing, conscience anesthetizing shades of gray.

Sasquatch was put to sleep last week, in an apt metaphor for our moral sensibilities. The malamute was destroyed, not executed. Programmed by nature or training, animals aren't responsible for their behavior. People are. But how can they understand that if no one is ever held accountable?

THE RELIGION-FREE WORKPLACE

How close are the "thought police"? Perhaps a lot closer than you think. Perhaps as close as your office.

The Equal Employment Opportunity Commission (EEOC) is currently reviewing Proposed Guidelines on Harassment based on, among other things, religion. If the proposed guidelines are approved, they will take effect as final rules by which claims of harassment are determined.

The EEOC release states that the proposed guidelines only clarify EEOC's position on the issues. An EEOC letter states that the guidelines "do not set forth new law." In fact, they depart, sometimes radically so, from

existing law. This will result in employers banning any type of discussion or expression of religion in the workplace, creating a kind of "first amendment free zone."

The proposed guidelines state that harassment on the basis of religion (as well as race, color, gender, national origin, age or disability) constitutes employment discrimination. This sounds fine in the abstract. It is when EEOC starts defining terms that the trouble begins.

"Harassment" is defined as "verbal or physical conduct that denigrates or shows hostility or aversion toward an individual because of his/her ... religion, ... or that of his/her relatives, friends, or associates," and creates an intimidating, hostile or offensive work environment, "... or otherwise adversely affects an individual's employment opportunities."

This, alone, raises a myriad of questions. How does an employer know what the religious beliefs of an employee (let alone "his/her" relatives, friends or associates) are, or how they may be offended, unless the

AFA matching funds offer turns out to be a hoax

An offer for a matching grant of up to one-half million dollars to American Family Association was an apparent hoax. Both the FBI and postal authorities have been notified.

AFA was approached last summer by a person identifying himself as Paul Andresen with EBN Corporation in Miami, Florida. Andresen offered to match gifts to the ministry up to \$500,000. The offer was investigated as much as possible and a Miami accountant was designated to handle the transaction. Andresen said he represented an anonymous benefactor who wanted to give ten organizations a total of \$500,000 each.

When the deadline came to meet the grant, AFA learned that Mr. Andresen's phone had been disconnected.

Other groups expecting funds included American Indian Heritage Foundation, World Vision, Health Crisis Network, and Future for the Children.

The fraud did not affect AFA financially since AFA does not spend money it does not have.

Music writer explains message of grunge rock

Chicago Tribune rock critic Greg Kot believes that the discordant music of popular "grunge" bands like Smashing Pumpkins, Nirvana and Pearl Jam express the angst of "a generation spurned" by the breakdown of social and family life.

Unlike the 60s when popular music channeled young people's despair into "call for action" on issues like the civil rights and anti-war movements, today's "alternative" music is "directed inward, a howl of despair or frustration rather than a rallying cry," Kot recently wrote.

Kot quoted Kurt Cobain, 26, of Nirvana, one of the country's

hottest bands: "Everyone's parents got divorced, their kids smoked pot all through high school, they grew up during the era when there was a massive Communist threat and everyone thought we were going to die from nuclear war, and more and more violence started to infuse our society....All these kids my age found themselves asking the same question at the same time—why the [expletive deleted] are my parents getting divorced? What's going on?"

Judge rules for AFA affiliate in prayer case

Monmouth County, New Jersey, officials cannot require The Freehold Area American Family Association to buy a million dollar insurance policy before they grant permission for a public prayer gathering, according to a judge's ruling. The judge also ordered that the county pay attorney's fees associated with the case.

The AFA affiliate organization was making plans for the National Day of Prayer in May, 1993, when county officials said the insurance policy was required. The requirement was seen as a ploy to prevent the group from gathering in front of the Monmouth County Hall of Records for 20 minutes of prayer. A suit was filed against the county in U.S. District Court.

Geffen to pay victim's son

The son of a man killed by followers of Charles Manson said Geffen Records has agreed to turn over any royalties earned by a Manson song on the new album by rock band Guns N' Roses.

Bartek Frykowski's father, Voytec Frykowski, was slain with actress Sharon Tate and six others by followers of cult leader Manson in 1969. Frykowski will receive the royalties to satisfy a 1971 judgment for \$500,000 he won against Manson and his followers. The judgment has now grown to \$1.2 million.

The Geffen record label and Guns N' Roses came under fire when it was learned that "Look At Your Game, Girl," a tune written by mass murderer Manson could earn the convicted killer \$62,500 for every million albums sold.

Two adults in three think it is possible for communities to agree on basic values to be taught in local schools, according to a Gallup poll. While some are skeptical that agreement could ever be reached on what values to teach, there are a number of bedrock values supported by 90% of the adults: honesty, the value of democracy, patriotism, caring for family and friends, moral courage, the "golden rule," and acceptance of people of different races and ethnic backgrounds.

Video influenced murder of two-year-old in England

While the murder of Liverpool, England's two-year-old James Bulger by two 11-year-olds was widely reported around the world, important details never made the headlines in the U.S.

According to the judge who sentenced the two young murderers, an American produced horror video entitled **Child's Play 3** gives the clearest explanation for the brutal murder. **Child's Play 3**, which depicts astonishing parallels to the actual crime, was the last video rented by one of the child murderers.

- The horror film depicts a baby doll who comes to life and has blue paint splashed in its face. James Bulger had blue paint put on his face.

- The film depicts a kidnapping. James was first abducted by his murderers.

- The film climaxes with two young boys "murdering" the doll on the train while mutilating the doll's face. James, left by his murderers on a railroad track to be struck, was first mutilated and bludgeoned by the boys.

A woman who bragged to a friend that she was known as "the fire starter" was arrested a short time later on charges of being one.

Police say the Ft. Lauderdale woman had set her friend's apartment ablaze just moments before a conversation about the 1984 movie **Firestarter**, an adaptation of a Stephen King novel in which a young girl possesses the power to start fires. As fire

fighters were on the scene, the woman returned to the area and began talking to one of the investigators about the movie, police said.

An estimated 2,000 McDonalds restaurants refused to participate in a corporate promotion of the film **Wayne's World** last December. Many franchisees balked at carrying the video which endorses a lifestyle of promiscuity, irresponsibility and profanity for teenagers.

Homicide expert links films, serial killers

Many of America's most notorious serial killers, including Jeffrey L. Dahmer, were influenced by Hollywood films that graphically depict violence, a homicide expert recently said.

"Hollywood is creating problems with some of the stuff they're coming up with," retired FBI agent Robert Ressler said at a police conference. "Movies like **Silence of the Lambs**, the **Death Wish** series and all the slasher films are causing mentally unstable people to go over the edge," he said. In a 20-year career with the FBI Ressler interviewed most of the nation's most infamous serial killers including Dahmer, John Wayne Gacy, David Berkowitz and Ted Bundy.

Park Dietz, a forensic psychiatrist who testified for the prosecution during Dahmer's trial, said Dahmer would watch such movies as **Hellraiser II** before going out to cruise for victims "to get into the right mood, the right spirit." Ressler said **Taxi Driver** was a favorite of Berkowitz.

Two teens sentenced in "movie" killing

Two teenagers accused of robbing and killing a motorist in Wisconsin after getting "hyped up" watching a movie received lengthy prison terms recently.

The boy that did the shooting got life in prison with no possibility of parole for 45 years; the other received 25 years and will be eligible for parole in about six years.

"What we have is two kids who decided to see a movie and write their own sequel," the judge said.

Authorities say the teens watched the crime drama **Menace II Society** before trying to rob a 50-year-old man as he paused at an intersection. The man was shot to death as he tried to drive away.

Taxpayers fund abortions for federal workers

Nine million federal employees now may choose abortion coverage as part of their health insurance plan. Breaking a long-time restriction on abortion coverage in federal employee health plans, the Senate passed and the President has signed into law the new Federal Employee Health Benefits Program (FEHBP). Since federal employees' salaries and the employer's portion of their health plans are paid through general revenues, every U.S. taxpayer will help finance abortions. Monies for the FEHBP are allocated through the Treasury and Postal Service Appropriations Act.

Pro-life groups banned from educators' meeting

Organizations which oppose abortion were banned from the annual state convention of the Minnesota Education Association (MEA) last October. A spokesman for Minnesota Citizens Concerned for Life, which has rented a booth at the convention each year for nearly two decades, said, "...the MEA's close-minded pro-abortion stance tells us that Minnesota school children are in danger of being propagandized, rather than educated, on the issue of abortion."

Enforcement of new law contradicts intent

Last year, millions of people called and wrote Congress to demand that the military's ban on homosexuality be maintained. They were heard, and Congress enacted legislation that codified the ban. President Clinton signed the law on November 30.

BAN SUPPORTERS BETRAYED

Now that effort has been betrayed. On December 22, departing Secretary of Defense Les Aspin released implementing rules that undermine the ban. The new "Don't ask, don't tell, don't pursue" rules mirror the President's proposal, not the legislation passed by Congress. Some key differences:

- The law itself excludes anyone with even a "propensity" for homosexuality. Aspin's new rules reinterpret "propensity" to mean the same thing as "likelihood to engage in acts." This standard is narrower and will severely limit investigations and make it more difficult to discharge homosexuals.

- The law allows the Pentagon to ask recruits about their sexual orientation. The administration chooses not to ask.

- The law precludes service by homosexuals, even supposedly celibate ones. The rules, however, state that "homosexual orientation is not a bar to service entry or continued service unless manifested by homosexual conduct."

- The law relies on commanders to exercise discretion in investigations. But the rules prevent commanders from starting investigations without "credible evidence" of homosexual acts. Soldiers who frequent homosexual bars, march in homosexual parades, or have homosexual magazines in the barracks are no longer investigated without proof of physical homosexual contact.

- The law permits security investigations to continue unabated. However, the rules bar security clearance investigators from asking about sexual preference. Even firsthand information about homosexual misconduct uncovered during a routine inquiry cannot be used in discharge proceedings without the Secretary's permission.

FIAT ACCOMPLI

These differences suggest the administration is trying to accomplish through bureaucratic fiat what it couldn't win in Congress or the court of public opinion. In tandem with the more liberal Pentagon rules, the

Justice Department is disregarding the intent of the old policy in the courts, ignoring key evidence and refusing to appeal decisions, casting shadows over the future of the new law.

Administration lawyer Mark Levy misstated the military's long-standing policy in the recent appeal of the case of Navy Petty Officer Keith Meinhold. Levy argued that the policy does not bar all homosexuals from serving. Instead, he argued, the policy excludes only those who have engaged, or are likely to engage, in sexual behavior that disrupts the military mission.

The government's attorney in the case of Joe Steffan, dismissed from the Naval Academy in 1987 after admitting his homosexuality, argued for a distinction between homosexual "attraction" and "desire." The attorney said that a person might be attracted to a person of the same sex and thus have a "homosexual orientation," yet that person might not "desire" to engage in homosexual conduct. He described this person as a "celibate homosexual," ignoring Steffan's own published admission of homosexual activity.

SHIPPING OUT TRADITION


Meanwhile, the Navy announced on

December 1 that women will begin serving on combat ships this June. The announcement followed the repeal of the combat exclusion law (Section 6015, Title 10, U.S. Code), ignoring the recommendation of the 1992 presidential commission on women in combat.

Eight ships, including the aircraft carriers USS Dwight D. Eisenhower and USS Abraham Lincoln, are scheduled to begin assigning women this summer. Overall, the Navy plans to have 400 to 500 women aboard three carriers by the end of 1994.

The American people have made clear their objection to lifting the ban on homosexuality, and have not clamored to put women into combat. If these policies are not reversed, the military's combat capacity will be damaged and the armed forces will become the vanguard of radical social engineering.

Word Abuse – a political lexicon

A political way of thinking has so permeated the American consciousness that it has changed the way in which we use English.

Below is a lexicon that shows how certain words are used by major American news papers, by the electronic news media (especially television), and by many individuals in public and private debate.

Conservative: A person with selfish motives.

Liberal: A person with altruistic motives. *(In 11 years of doing talk radio, I never once spoke to a liberal who believed that a person who voted for Ronald Reagan or George Bush could be motivated by altruism. Republicans, by definition, "vote with their pocketbooks.")*

Ultra-Conservative: A person who is too conservative.

Ultra-Liberal: Term not used. One can not be too liberal.

(I read six newspapers a day, and countless journals. I have never encountered the term "ultra-liberal" or "arch-liberal." I read or hear about "ultra-" or "arch-conservatives" all the time.)

Christian Right: Contemptible people who always try to impose their values on other Americans.

Liberals: Idealistic people who never try to impose their values on other Americans.

(When Christians try to put their values into law—for example, preventing government funds from going to what even most liberals would consider to be obscene art – they are attacked for trying to impose their values on others. However, when liberals pass laws reflecting their values – e.g., forcing states to allow gay and lesbian couples the same right to adopt children as married couples – that is not regarded as imposing values, but simply the right thing to do.)

Abortion: A form of birth control.

Women's Rights: Supporting the right to destroy a human fetus for personal convenience.

Animal Rights: Opposing the right to destroy a rabbit for cancer research.

(In our time, the intellectual and moral norm is to regard a baby seal as of infinitely more worth than a human fetus.)

Fetus: An unborn baby that is to be aborted.

Baby: An unborn baby that is not to be aborted.

(When a woman is pregnant and wants to give birth, no one asks her, no matter how early in the pregnancy, "So, how's the fetus doing?" We only use the term "fetus" when we plan to destroy it. Otherwise we use "baby" from the first day of pregnancy.)

Woman, Authentic: A woman who holds liberal views.

Woman, Inauthentic: A woman who does not hold liberal views. *(Gloria Steinem called Texas Sen. Kay Bailey Hutchison a "female impersonator" [USA Today, June 11, 1993]. Ms. Hutchison is a conservative Republican.)*

Censorship: The refusal of the government to fund a radical artist. *(Censorship was always understood as the prohibition of expression. According to the arts community and its supporters, however, "censorship" now means governmental refusal to fund a work of art.)*

Censors: Christians who boycott violent TV shows.

Social Activists: Hollywood actors who boycott Colorado.

Hitler Youth: People who, among other terrible things, drowned out liberal speakers with whom they disagreed and destroyed liberal newspapers with which they disagreed.

Progressive Students: People who, among other good things, drown out conservative speakers with whom they disagree and destroy conservative newspapers with which they disagree.

(Thus, the progressive students who stole all copies of the conservative paper at the University of Pennsylvania were exonerated, and the guards who stopped them were chastised for interfering with a student protest.)

The Soviet Union (before its fall): An alternative system of government that should not be condemned with such Cold War labels as "evil empire."

The Soviet Union (after its fall): An evil empire.

(Since the fall of the Soviet Union, nearly everyone now speaks of communism in the terms that "Cold Warriors" used.)

Religious Extremist: A person who is too religious, usually meaning that the person holds traditional religious beliefs and is politically active.

Secular Extremist: Term not used. One cannot be too secular.

(Those who call for the right to mention God's name in high-school graduation exercises are religious extremists, while those, like the American Civil Liberties Union, who litigate against schools that post the Ten Commandments on their walls are never described as secular extremists.)

Sexist: A man who disagrees with women who hold liberal views. (For the term for a woman who disagrees with women who hold liberal views, see "Woman, Inauthentic.")

(This is why Sen. Edward Kennedy, one of the most notorious womanizers in American public life, is never called sexist: He doesn't disagree with liberal women's groups. However, men who treat women beautifully and respect them as equals, but do not agree with the Nation Organization for Women, are sexist.)

Tolerance: Openness to all ideas on the left.

Rage: The excuse for violence committed against innocent people by members of an aggrieved minority.

(Since the thugs who terrorize Turkish immigrants in Germany are white, their actions are never understood in terms of rage, only condemned [correctly] as thuggery. But when black thugs terrorized Korean immigrants in Los Angeles, their actions were constantly understood in terms of their "rage.")

Victims: Nearly all blacks and women, but essentially members of every group except white heterosexual males. The group must also be associated with liberal activism.

(Thus Korean-Americans, though the primary victims of the Los Angeles riots, are never referred to as victims; they hold conservative views.)

Ideal Family: Any unit of people.

(To define the ideal family as a married mother and father with children is to be intolerant and judgmental.)

Progressive View of Humanity: Dividing people by their race, gender and class.

Reactionary View of Humanity: Dividing people by their values and behavior.

Blacks (Authentic): Blacks who hold liberal views – in particular, that America is racist and that racism is the greatest black problem.

Blacks (Inauthentic): Blacks who do not hold liberal views – especially if they hold that America is not racist and that racism is not the greatest

Conscientious objectors to trooper allegations jumped on Tower, Thomas, Nancy Reagan

Information for this article was taken from *Mediawatch*, January, 1994. *Mediawatch* is a publication of the Media Research Center, 113 South West St., Alexandria, Virginia 22314.

The revelations of four Arkansas state troopers who declared that then-Governor Bill Clinton used them to set up liaisons with women received a nearly identical amount of coverage as Clinton's last "bimbo eruption." The Jennifer Flowers story drew only 14 stories on the four network evening news shows in a six-day period. Likewise, the trooper story attracted only 22 stories in a 12-day period, nine of them on CNN.

Liberals suggested a right-wing conspiracy. *Time's* Washington Bureau Chief Jack Nelson cried foul on the PBS show **Washington Week in Review** on December 24: "There was a conspiracy, in my

opinion, by right-wingers, including some right-wing journalists, to press this newspaper (Los Angeles Times) into running this story before it was ready to."

Some media outlets tried to avoid the story as tasteless and un-sourced. Many of those conscientious objectors have taken a decidedly different approach when the targets of leaks and gossip were conservatives.

Media outlets did not ignore unproven charges against Senator John Tower; or Kitty Kelley's gossipy book about Nancy Reagan; or Anita Hill's charges against Justice Clarence Thomas despite, as Wall Street Journal columnist Paul Gigot put it, "Ms. Flowers now has more corroboration than Anita Hill ever did."

1994 off to a bad start

The new year has had a bad start. The pro-life movement has suffered a major defeat before a unanimous Supreme Court; Congress has several measures before it which endanger positive values; and the Administration, despite President Clinton's rhetoric, continues its assault on the American family.

RICO

The U.S. Supreme Court recently ruled that the federal Racketeer Influenced and Corrupt Organizations (RICO) law may be used against pro-life demonstrators. The consequences that will likely flow from this decision are ominous. If RICO were in effect when Martin Luther King was alive he would have been considered a "racketeer." It is difficult to think of those who witness for life at abortion clinics as racketeers on par with mafia chief-tain John Gotti. But that is the likely effect of this decision. Attorney General Janet Reno, in Senate testimony, has earlier indicated a willingness to use the full force of federal law to "protect" the so called right of abortion. Now she has an additional weapon – of nuclear proportions. What is good for the goose is good for the gander, however. So RICO will also be used against liberal groups like Act-Up, the radical homosexual group that desecrated St. Patrick's Cathedral in New York City. Thus, it is likely that an unusual coalition will urge Congress to protect demonstrators regardless of their cause.

Child pornography

The child porn case which the Clinton Administration is using to undermine the federal child pornography law, *Knox v. U.S.*, is now before the U.S. Court of Appeals in Philadelphia. Att. Gen. Reno asked the Court to throw out the conviction of child pornographer Knox (convicted during the Bush Administration) so that the case could be retried under her weakened interpretation of the law. The Court did not go along with her request, however, and ordered both sides to file legal briefs. Members of the U.S. Congress concerned about the Administration's soft-on-child-porn stance have received Court permission to file a brief also. Every Member of Congress should be encouraged to sign the brief, called friend of the court brief. A hearing will likely be held in March or April with a decision soon.

Health care

The Congressional issue of greatest concern to the family is the Clinton health plan – socialized medicine. Euthanasia is a likely by-product of the plan because the plan is greatly underfunded. Confidential White House documents reveal that it would boost the federal deficit by as much as \$810 billion between 1996 and 2000. Thus there will be pressure for health care rationing. Many in need of care will not get it and involuntary euthanasia will be the result. The plan is also the vehicle that the Clintons and the pro-abortion movement hope to use to force abortion on every American. Every employer and every employee will pay for abortion as part of a basic benefit package. America has the best health care system in the world and there is no health care crisis, contrary to the President's claims.

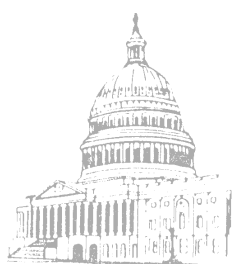
There will be one, however, if government takes over all health care in America.

Hyde Amendment

A decisive pro-life congressional victory in the passage of the Hyde Amendment during the 1993 legislative session was, in part, undone by a Clinton Administration directive at Christmas time. The Hyde Amendment prohibits federal funding of abortion except in cases of life of the mother, rape and incest. The Administration's order to state Medicaid directors insisted that their programs fund abortions in cases of rape and incest. The intent of the Hyde Amendment, however, was that states have the option to fund in cases of rape and incest. Many state laws prohibit publicly funded abortions except in cases when the life of the mother is threatened and thus Clinton's order would require states to violate their own laws. Look for legislation to be introduced in Congress to overturn this arrogant directive.

Military homosexual ban


Although Congress passed and the President signed a strict law last year prohibiting homosexuals in the military – the so called "don't ask, don't tell" policy – the Clinton Administration is hard at work in an effort to undermine the law. New Defense Department regulations promulgated by the Administration, which are supposed to be used to enforce the law, actually provide several loopholes, unintended by Congress, which benefit homosexuals. The new regulations state, for example, that "sexual orientation" is a private matter. Homosexuals are permitted, under the regulations, to march in gay parades, frequent gay bars, read homosexual magazines and continue to serve in the military. Since these regulations turn the new law on its head, Congressional action – at least



legislative hearings on the regulations – is likely.

Balanced budget amendment

The Senate is set to take up a balanced budget amendment to the Constitution, S.J. Resolution 41. A House vote is expected in the spring (H.J. Resolution 103). An unusual coalition of liberals and conservatives is backing the amendment which has a good chance of passage. A two-thirds vote in both Houses followed by ratification of three-fourths of the state legislatures is required for passage. Powerful forces are aligned against this critical measure, including the Clinton Administration. President Clinton wrote Senate Majority Leader George Mitchell a letter late last year to express his "firm opposition" and claimed that addition of the amendment to the Constitution would "promote political gridlock and would endanger our economic recovery." That's a stretch! The national debt, which could be eliminated with a balanced budget amendment, is a major reason for our nation's cyclical economic problems. Every American family is harmed by the debt and deficit spending. The federal debt is currently \$4.3 trillion or about \$17,000 for every man, woman and child. It increases every day. Forty-five percent of the dollars that the average citizen sends to Washington, D.C. in taxes goes to finance the federal debt, according to Idaho Senator Larry Craig.

End welfare for single women having children

■ **System may not cause illegitimacy, but it makes out-of-wedlock births economically viable.**

In a recent Wall Street Journal article, social scientist Charles Murray called for ending the current welfare system. It had an explosive effect and set off a chain reaction that in a dozen weeks has transformed the welfare debate. We are now at one of those rare political moments when a fundamental, even radical, and positive change in public policy is possible. That reform of this magnitude is even possible can be explained by three things:

- **Widespread acceptance of overwhelming empirical evidence:** The current system is a complete failure. We have spent enormous sums over the past three decades on welfare programs and what do we have to show for it? An underclass which is much larger, more violent, more poorly educated and which consists of many more single-parent families.

Reaction to Murray has been overwhelmingly favorable, including positive reaction from unlikely places. Here's what President Clinton said in a recent interview about welfare's fiercest and most prominent critic: "(Murray) did the country a great service. I mean, he and I have often disagreed, but I think his analysis is essentially right.... There's no question that (ending welfare for single mothers) would work. The question is is it morally right?"

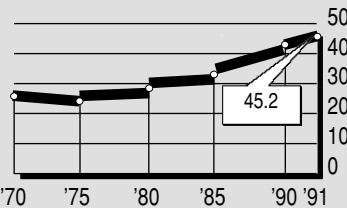
Clinton's firm embrace of the Murray analysis means the intellectual debate over welfare policy is essentially over; we are now debating the relative merits of changing the current system vs. dismantling it.

- **Acknowledgment among experts in the field** that a strong link exists between social pathologies, exploding rates of illegitimacy and welfare payments to single mothers. By the end of the decade according to the most reliable projections, 40% of all American births and 80% of minority births will be illegitimate. These numbers have frightening social implications.

Welfare may not cause illegitimacy, but it does make it economically viable. There

Out-of-wedlock-births Illegitimacy on the

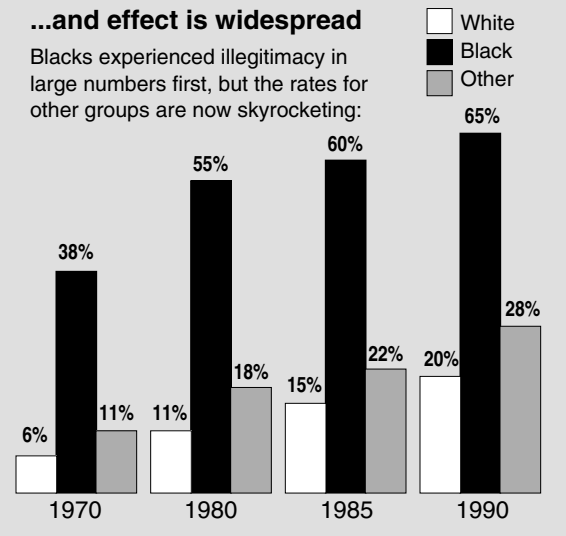
Illegitimate birth rate has been exploding for women ages 15-44. Rates per 1,000 unmarried women:

is hardly any question anymore that illegitimacy rates would fall, probably dramatically, if payments under the Aid for Families with Dependent Children program were stopped. Welfare is illegitimacy's economic life-support system.

- **Agreement on an important moral principle:** Having children out of wedlock is wrong—not simply economically unwise for the individuals involved, or a financial burden on society, but morally wrong.

Even Secretary of Health and Human Services Donna Shalala, she of impeccable liberal credentials, said in a recent interview that "I don't like to put this in moral terms but I do believe that having children out of wedlock is just wrong."

Unfortunately it is not at all clear that politicians, including most Republicans, are willing to propose legislation that is intellectually consistent with the arguments and analysis. Most proposals now on the table miss the essential point of welfare reform — not to ensure tougher work provisions and job training but to go after, root and branch, a system that fosters illegitimacy and its attendant social pathologies.

Republicans should propose in this congressional session to end welfare for anyone having a child out of wedlock. Our preference is to end, one year after the legislation is passed, all forms of economic support for single mothers who have new children, including AFDC payments, subsidized housing and food stamps; further, end at a specific date all forms of assistance for those single mothers currently on welfare, end visitation rights of illegitimate fathers and change tax codes to make them more favorable to mar-

riage and children.

The specifics are less important than the end game; sometime soon we want welfare to end, and when it does we can judge these policies, and their broad social consequences, against reality.

Making adoption easier is an essential and compassionate part of this effort. Adoption is the best alternative we have to protect a child's interest in a post-welfare world. The demand is virtually unlimited, but society has made adoption exceedingly difficult. Lifting restrictions on interracial adoption and easing age limitations for adoptive parents will, among other measures, help ensure that large numbers of children will be adopted into good, stable, loving homes. And for older children, we must invest generously in the kinds of orphanages and group homes that provide order and care.

Ending welfare in this way is prudent, humane and politically smart. It is prudent because the social science evidence is in: Illegitimacy is the surest road to poverty and social decay. And welfare subsidizes and sustains illegitimacy.

It is humane because many more people would live far better lives if we scrapped an entire system that subsidizes out-of-wedlock births. Here's "tough love" on a large scale: End welfare, and young girls considering having a baby out of wedlock would face more deterrents, greater social stigma and more economic penalties arrayed against them if they have babies. There would therefore be far fewer births to unwed mothers, and far greater life opportunities for those girls.

Arkansas to proclaim 'Christian' week ACLU questions constitutionality as Huckabee defends signing

Baptist minister-turned-lieutenant governor Mike Huckabee signed documents proclaiming February 27-March 2 "Christian Heritage Week," a move the American Civil Liberties Union says might be unconstitutional.

Huckabee, acting governor in Gov. Jim Guy Tucker's absence out of state, said he agrees with the ACLU in the separation of church and state doctrine, but he sees nothing wrong in the proclamation.

"You have a Black Heritage Month and that is not offensive to people who are not black, you have an Indian-American heritage (observation) that's not offensive to people whose grandfathers were in Custer's army," Huckabee said. "I can't believe anyone would object to that. It's beyond me. If the atheists want to have a proclamation day - maybe April 1 would be a good day."

Huckabee said he informed Tucker and his staff several weeks ago he intended to conduct a proclamation ceremony while the governor was out of state. Tucker left the state to attend the National Governors Conference in Washington and a scheduled medical checkup.

Rita Spillenger, director of the Arkansas ACLU, said of Huckabee's intent to sign the proclamation: "It is outrageous. We are looking into legal remedies to the situation. I think the taxpayers should be outraged the lieutenant governor is abusing his power in the governor's absence. Nobody is denying

the Christian heritage of this country, but are you declaring this is therefore a Christian country?"

She said the effort was part of, "a whole movement on the radical right trying to prove this is really a Christian country."

Attorney Brenda Vassaur Taylor of Altheimer, Arkansas, said she asked Huckabee to sign the proclamation. She said others were involved in the effort, but that it was not an organized group.


"The purpose would be to give an opportunity for school students and adults to look at the founding fathers," she said.

Taylor said she never learned in her history classes that the founders of the United States and of Arkansas praised God so often in their political writings.

The proclamation quotes the Arkansas Constitution's preamble that says the people of the state are "grateful to Almighty God for the privilege of choosing our own form of government." It also quotes Benjamin Franklin, who cited Psalm 127 in the Constitutional Convention of 1787, and George Washington, who said the country was, "animated alone by the pure spirit of Christianity."

Catherine Millard, an author and founder of Christian Heritage Tours in Washington, said 13 other states - including Tennessee, Texas and Missouri - have authorized similar proclamations. Spokesmen for the governors of Texas and Missouri said their proclamations declared a week in the fall as Christian Heritage Week.

cause anything less than calling for an end to welfare will probably ensure that the debate will be conducted on Bill Clinton's terms. That's a sure political loser. On the other hand, calling for the complete abolishment of AFDC is an opportunity for Republicans to make a clean principled break with an old failed system; seize the mantle of true reform; and help return our nation to an older, better time, when moral common sense was the touchstone of social policy.

Our welfare system is the most pernicious government program of the past quarter century. (It is also, ironically, one of the most well-intentioned.) We have lost large parts of an entire generation because of the terrible human wreckage left in its wake. Enough is enough. It's time to pull the plug.

The deceitfulness of pornography addiction

The addictive process has many stages common to all addicts. Addiction is cunning, baffling, and progressive. I don't believe an addict wakes up one day and says, "I think today I'll become a pornography addict." Addiction can be slow and very powerful. It usually starts in the home at a young age with pornographic magazines and escalates over the years into full blown compulsion including videos, phone sex, theaters, and acting out. In the end addiction leads to loneliness, shame, guilt, and overwhelming daily anxiety.

During this progressive time, the addict learns to minimize his problem. When confronted about his behavior, or even when not confronted he will defend himself with such comments as "I don't have a problem," "It's a little problem," "It's normal to have this behavior," or "It's your fault for my behavior."

Whatever the excuse, defense, or reasoning, the bottom line is this: Addiction to pornography is sinful. The Lord tells us in Galatians 5:17, "For the flesh lusts against the Spirit, and the Spirit against the flesh; and these are contrary to one another, so that you do not do the things that you wish."

Porn addicts usually seek help only when they have hit emotional, mental, or spiritual bottom. For some, the bottom is addressing daily behaviors before they get out of hand and for others it can be a bottom of revealing consequences.

What is your bottom? Do you have a problem with pornography? Do you want help and don't know where to receive it? The Lord will deliver you from this problem with the help of other Christians. Christian counselors who know about pornography and the addiction to it. Remember God loves you and will take care of you even through the rough waters. *God bless.*

cal hit, but the police drama is losing money, ABC president Robert Iger said Monday.... 'The revenue it's bringing in is less than that of a program with its ratings. It's losing money,' Iger said. 'The reason is content. There are signs of some support from traditional advertisers, but how dramatic that support will be won't be [known] until the show comes back next fall.'"

"Iger said ABC has no plans for another 'R-rated' series as, **NYPD Blue** has been called. 'I have not second-guessed our decision to do this show, but we're not sitting around saying 'When are we going to do the next one?'

'When we decided to do **NYPD Blue**, we didn't say we were going to vastly change our standards. This sets a new standard for quality. It's not a relaxation of our standards.'"

"ABC is now admitting they lied to the American public," said AFA president Donald E. Wildmon. "If they will lie about one program, then it certainly leaves open the possibility they will lie about other programs including their news," Wildmon said. He said the fact that ABC is now admitting the obvious means that the network would just as quickly lie to the public about other matters if they feel it benefits them financially.

AFA has also learned that at least one ABC affiliate, and probably many more, now consider running the program a big mistake. AFA continues to inform the advertisers about **NYPD Blue** and plans to make another major effort regarding the program this summer.

"ABC expects advertisers to flock to the program next fall and to pay big rates. Nearly every ABC affiliate which has carried the program has lost money on it. We must thank the ones which did not carry it and renew the fight against the affiliates which do carry the program," Wildmon said.

ABC Entertainment president Ted Herbert said that AFA's "biggest influence has been on local stations...." He also said that ABC hopes to break even on the program by the beginning of next season.

"The battle over **NYPD Blue** is far from over," Wildmon said. "It is vitally important that our supporters continue their efforts. ABC has agreed to fully fund the first sixty-odd episodes of the program. If we will continue our efforts we can cost ABC more than \$60,000,000 in this battle."

Approximately 45 ABC affiliates still refuse to carry the series because of the porn sex scenes, the foul language and the extreme violence.

The existing laws allow discrimination complaints on the basis of religion. A claim must be based on (1) a good faith belief that an employment requirement is contrary to his religious belief, (2) he has informed his employer about the conflict, and (3) he was discharged or adversely affected because of his refusal to comply with the requirement. The employer may then prove that it could not accommodate the employee's beliefs without undue hardship to the business. A harassment claim requires more stringent evidence by the employee, since it is viewed as a more serious claim.

The proposed guidelines eliminate any requirement that the employee inform the employer of the unwelcome conduct. They also add provisions for evaluating conduct, from the perspective of one offended (the "victim mentality"), which are not an accepted part of the present laws. Finally, the proposed guidelines forsake existing law, by making the employer liable for harassment even if the employer did not know of the conduct, if there is no policy against harassment that is "clearly and regularly communicated to employees," or fails to establish an acceptable (to EEOC) complaint procedure.

Unlike existing law, the proposed guidelines impose on the employer "an affirmative duty" to maintain a workplace free from harassment.

There is no practical way an employer can meet this "affirmative duty" unless the employer completely bans the discussion, dissemination or expression of any religious belief or practice. This, if mandated by the government, would violate both free speech and free exercise of religion clauses of the first amendment.

What can be done?

1. Write to EEOC, asking for reconsideration of the Proposed Guidelines on Harassment Based on Race, Color, Religion, Gender, National Origin, Age or Disability.
2. Write to your Senators and Representative, urging them to require review and reconsideration of the Proposed Guidelines on Harassment Based on Race, Color, Religion, Gender, National Origin, Age or Disability.

black problem. Such blacks also are known as Uncle Toms.

Racism: See "White Racism."

Racist: A white who does not agree with a position held by the civil rights leadership.

(To cite one of innumerable examples, a number of black leaders have labeled support for school vouchers as racist, even though school vouchers tend to be supported more by inner-city blacks than by white suburbanites. But since the liberal black leadership is opposed to vouchers, support for it is a racist.)

White Racism: Redundant term.

Black Racism: Term not used. It does not exist – an idea perpetrated by white racists.

Poverty: The reason for murder, rape and carjackings.

Greed: The reason for embezzlement, insider trading and other white-collar crimes.

Minorities: Members of groups whose spokespeople are angry at America.

Thus, Cuban-, Japanese-, Korean- and Jewish-Americans are rarely referred to as minorities.

Community: A term created in order to imply that members of a victimized group all hold the same (liberal) views.

Civil Rights Organizations: Organizations that hold white people responsible for the majority of blacks' problems.

Feminist Organizations: Organizations that hold men responsible for the majority of women's problems.

"Blaming the Victim": Making moral demands of any member of a victimized minority (see "Victims").
