Please be sure you are familiar with your 4<sup>th</sup> edition ENPC textbook, particularly the skills portions, as a great deal of time is spent discussing those skills.

**Pre-testing:** You'll be required to pre-test for entrance into this course unless you have passed a 4<sup>th</sup> edition ENPC within the last 90 days with a written score of 90% and skills score of 85%. Arrangements will be made for you to complete the required pre-testing prior to the course.

Following the Instructor course you'll need to be monitored in a 2-day ENPC Provider course to complete your Instructor requirements. Further details will be provided for you during the course.
