### **GEDA's Response:**

Finishes for these rooms will be as follows:

- 1. Floors: Stained concrete, color TBD and coordinated with Owner at no additional cost
- 2. Walls: Paint-eggshell, color to be determined and coordinated with Owner at no additional cost
- 3. Ceilings: Flat black to include ductwork, piping, and conduits (except 209-P1 ductwork, piping, and conduits)

#### Question No. 89.

Please clarify if "Buy American" product/s is required for this bid.

## **GEDA Response:**

"Buy American" is not required for this IFB.



### Question No. 90.

Section 3.17 of Contract: Please provide liquidated damages or the contract form stating liquidated damages. Or provide specifications with liquidated damages as stated in Article 14.

### **GEDA's Response:**

Article 14 of the Form Contract, attached as Attachment G to IFB No. 13-004, is hereby replaced in its entirety with the following:

# ARTICLE 14. LIQUIDATED DAMAGES

The standard clause in the Guam Procurement Regulations regarding liquidated damages has been replaced with the following:

If CONTRACTOR shall neglect, fail or refuse to obtain a certificate of occupancy for the Project by December 12, 2014, CONTRACTOR does hereby agree, as part of the consideration for the awarding of this contract, to pay to GEDA the amount of One Thousand Five Hundred Dollars §1,500.00 per calendar day thereafter, not as a penalty but as liquidated damages. The said amount is fixed and agreed upon by and between Contractor and GEDA because of the impracticability and extreme difficulty of fixing and ascertaining the actual damages GEDA and the Government of Guam would in such event sustain.

It is further agreed that time is of the essence of each and every portion of this Contract and of the specifications wherein a definite and certain length of time is fixed for the performance of any act whatsoever; and where under the Contract an additional time is allowed for the completion of any work, the new time limit fixed by such extension shall be of the essence of this Contract. Provided, that CONTRACTOR shall not be charged with liquidated damages of any excess cost when the delay in completion of the work is due:

- a. to any preference, priority or allocation order duly issued by GEDA.
- b. to Excusable Events: and
- c. to any delays of Subcontractors or suppliers occasioned by any of the causes specified in subsections (a) and (b) of this Article.

Provided further that CONTRACTOR shall, within seven (7) calendar days from the beginning of delay give written notice as to the causes of the delay to the Contracting Officer, who will ascertain the facts and extent of the delay and notify CONTRACTOR within reasonable time of his decision in the matter.

CONTRACTOR must note that Guam by nature has frequent rainfall causing suspension of work. Said suspensions shall not qualify for time extensions unless the weather is unusually severe.
