Please note that program minimum requirement is 5 students registered. Programs meeting this requirement will be confirmed 1 week prior start date. If the minimum requirement is not met, the Program will be cancelled for the session on Program start day. Deposit checks will be refunded for any cancelled Program within 2 weeks of cancellation.

TUITION:

- I agree to pay the full tuition for the program to which I am registering as specified on the registration form no later than the first day of the program (After-School Classes, Preschooler Classes, Homeschooler Classes, Summer Camps and Introduction to Mandarin Chinese Module if offered that year) or on the dates specified as the Fall Session and Spring Session Tuition Payment Schedule (Weekend Program)

- I acknowledge that a \$25 late fee per week passed each installment date will be added to unpaid school year tuition; that students not current 2 weeks afterschool year tuition deadlines will be dropped from the program, and their spot released to wait-listed students
- I acknowledge that there will be no refunds or make-up sessions due to student absences. Teacher cancellations will be either made up or refunded on a pro-rated basis.
- I acknowledge that on Saturdays, after-care is no longer offered.
- For all programs, if pickup is not made ontime, an extra \$15 per child per hour will be charged starting 10mins after the scheduled pickup for your program.

LIABILITY:

- I hereby acknowledge that I have been advised and fully understand that certain elements of risks are inherent to the outdoor activities sponsored by **Live In French, LLC.**, and that my child(ren)'s participation in any program activities may entail risks of personal injury, death or damage to property. These risks include, but are not limited to: insect and animal bites and stings, tree house use and related activities, any hazards presents in nature, such as (but not limited to) low lying branches, sharp or hard objects, slippery surfaces, venomous fauna and flora, or weather events such as lightning or other extreme conditions.
- I release **Live In French, LLC.**, its staff and any related party - including but not limited to all facility or service providers - from any and all liability in connection with my child's/children's participation in any events and activities of the **Live In French, LLC.** camps and/or classes.
- I understand and agree that my release of liability to **Live In French, LLC.**, its staff and any related party - including but not limited to all facility or service providers - includes, without limitation, a release of all liability related to any accident to, allergic reactions of, injuries to, illness of or death of my child(ren) or any other third party (including other children or adults onsite), as well as any loss of or damage to property, while participating in any activities, camps or classes of **Live In French, LLC.**

damage or loss and attorneys' fees, arising or alleged to have arisen on account of any injury of persons or property damage or loss resulting from any acts or omissions of **Live In French, LLC.** and/or all related parties - including but not limited to all facility or service providers .
