## Guidelines for this event

1. A team can only qualify once and one entry per school. If a team wins or places at two events, the next place team will qualify. In the event the next team(s) are tied in overall points in that event, the tie will be broken using the following criteria (only two teams will be invited from the list of 8 qualifying tournaments):
  - 1.Head to Head matches within that event between the teams tied.
  - 2.Total number of matches won.
  - 3.Total number of sets won.

4.Total number of games won.

5.Coin Flip

2. Teams may consist of 7<sup>th</sup>, 8<sup>th</sup> and non-varsity 9<sup>th</sup> graders. A singles player or doubles team will not be permitted to play in both OSSAA state varsity tournament and this event. Also, a 9<sup>th</sup> graders can have played only limited number of JV or Varsity matches to fill lineups. No 6<sup>th</sup> graders will be allowed to play any sanctioned events!
3. The team that qualifies at these events must be the same team that plays in this JH state tournament. If an injury occurs (or some other misfortunate circumstance which precludes a player from playing that qualified with the team), please contact the director and this will be dealt with through a committee vote.

**One Exception.** If a team has already qualified and wins a later qualifier outright, they have the choice of which line up to use at this event. It has to be one of the other, it **cannot** be a mix of both teams.

4. Only Full Matches, Prosets and Matchbreakers / Ad or No-Ad will be used in consideration for seeding purposes at the state tournament.

Contact will be made with the qualifying teams as the season proceeds.
