#### **Email lodgement is preferred**

Submissions lodged by email must be accompanied by the *Submission Cover Sheet*. The preferred format for emailed submissions is Microsoft Word. If providing hard copies, they should be typed or clearly written on A4 paper.

#### Confidentiality and publication of submissions

 Submissions may be published on the <u>Department of Health</u> website (<u>www.health.gov.au/internet/main/publishing.nsf/Content/ohp-human-health-provisions-biosecurity-bill</u>) unless you request otherwise.

Please indicate clearly on the submission coversheet if you wish for it to be treated as confidential, either in full or part. Confidential material should be provided under a *separate cover sheet* and clearly marked 'IN CONFIDENCE'.

The Australian Government reserves the right to refuse to publish submissions, or parts of submissions, which contain offensive language, potentially defamatory material or copyright infringing material. A request may be made under the *Freedom of Information Act 1982* for a submission marked confidential to be made available. Such requests will be determined in accordance with provisions under that Act.

Personal information provided by you in your submission will be used by the department for the purposes of the review. Contact information, other than your name and organisation (if applicable) will not be published. Your name and organisation may be published on the department's website to identify your submission.
