- Saturday, July 18, 2015: 10:00am – 11:00 pm
- Sunday, July 19, 2015: 10:00am – 2:00 pm (optional, no tear-down during this time)

FEES:

- 2015 Kimberley & District Chamber of Commerce Members: \$75.00 (\$78.75*) / per 10x10 space for both days
- Non-members: \$225.00 *(\$236.00) / per 10x10 space for both days

PAYMENT:

Upon your approval you will be asked to make your payment via Cheque, Cash, VISA or MASTERCARD prior to the start of the event.

IMPORTANT INFORMATION:

1. Please bring all your own supplies (tables, tents, chairs).
2. Make sure your tent is secured in case of windy conditions (you will be on pavement so please bring appropriate security for your tent, for example cement blocks, sand bags).
3. Electricity provided for food vendors only (limited). Please note on application if required.
4. Vendors are responsible for managing their own garbage and recycling.
5. Parking will be limited but there will be a load in/out area for your use.
6. Stall assignment will be sent to you upon approval of your both. (locations are first come first served, with payment.)
