### 3. Hazards identification

*EMERGENCY OVERVIEW Irritating to eyes, respiratory system and skin.*

*Potential Health Effects Eye:*

*Causes eye irritation. May cause chemical conjunctivitis.*

*Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water. Wash mouth out with water.*

*Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid. Do NOT use mouth-to-mouth resuscitation.*
