#### ARRANGING YOUR TRAVEL

**PlazaCUBA** is a licensed organization and we are authorized to arrange travel to Cuba for all Americans. We offer our programs under an educational people to people license, ensuring that everyone travels legally with us.

We recommend that you travel directly from Miami to Cuba, which is legal with our travel authorization. We also recommend that you register and make your arrangements early. December is a popular vacation time creating issues with availability and higher costs associated with traveling.

We offer travel assistance, but you will be responsible for booking your Cuba flights. Once you register with us at PlazaCUBA, we will connect you to our travel agent to secure your seat on the Miami to Cuba flight. This group flight will arrive to Havana on December 13<sup>th</sup> and depart back to Miami on December 21<sup>st</sup>. We recommend that you register with us and book your flights early because December is a busy travel time.

You can usually arrange your entire trip through one of the agencies booking your Cuba charter, but it is generally less expensive to book the domestic flight on a travel website like Orbitz, and book only the Cuba portion through the listed agencies. There are generally only a few flights per day to Havana. For this reason, it is best to FIRST book your Cuba flights, then book the remainder of your trip. Be sure to allow plenty of time between your domestic and Cuba flights. Depending on your Havana flight schedule, we recommend overnights in Miami to allow the necessary window of time.

Plan to arrive in Cuba on Sunday, December 13th and depart on Monday, December 21st. There will be no activities or concerts on those travel days.

Please note: You will only be covered under PlazaCUBA's license for the exact dates of the program.

#### **REGISTRATION and PAYMENTS**

To register, fill out these attached forms and send it to us with your \$500 non-refundable deposit or full payment. Your registration will be processed when we have received the following:

- (1) Completed Registration Form
- (2) Signed License Requirements, Limits of Liability, and Cancellation Policy
- (3) Payment of \$500 deposit or payment in full. (Make checks to PlazaCultura. Do Not write "Cuba" on your check)
- (4) A copy of your passport (1<sup>st</sup> page only).
- (5) A copy of your Cuba flight itinerary (after you book your Cuba flight with our travel agent). It works well if you send the final email of flight confirmation from the travel agent.

The final registration deadline is October 12, 2015.

By this date, we must have all of the above paperwork and payments.

I understand that PlazaCuba reserves the right to refuse to accept or retain me as a participant. **CANCELLATION POLICY** I understand that my deposit is not refundable and that for cancellations made thirty-one (31) or more days prior to date of departure, total payments made minus the non-refundable \$500 deposit will be refunded. I understand that for cancellations between thirty (30) and fifteen (15) days prior to the date of departure, up to \$1,000 of the total payments made may be retained by PlazaCuba. Furthermore, I understand that for cancellations fourteen (14) days or less before the date of departure, that up to 100% of the program fee may be retained by PlazaCuba.
