## VOLUNTEER LIABILITY RELEASE AND INDEMNIFICATION AGREEMENT

I, \_\_\_\_\_, have volunteered to assist Anime St. Louis, an event organized and existing under the laws of Illinois, with the 2015 Anime St. Louis convention in a variety of capacities.

I have volunteered my time and services because of my support for Anime St. Louis and the anime fan community of St. Louis, and my desire to participate actively in the furtherance of its work. I intend this release and indemnity to be effective, regardless whether the claim of liability is asserted in negligence, strict liability in tort, or other theory of recovery. For myself, my estate and the personal representative thereof, my heirs and assigns, I covenant and agree to make no claim, nor to institute any suit, action or proceeding against either Anime St. Louis its officers, directors, or fellow volunteers, relating to any accident, incident or occurrence arising out of, or in connection with, my volunteer activities.
