MEET OUR NEW CEO

David Silber sees membership growth as key goal

David O. Silber, president of Golden Turtle Press in Richmond CA, will succeed Roy G. Green as chief executive officer of the American Contract Bridge League. The choice of the ACBL search committee was approved by the ACBL Board of Directors during their deliberations last week.

Roy Green, our present CEO, announced last year that he planned to retire in 1998 but would remain as CEO until his successor was selected and had some time to get acclimated.

The 55-year-old Foster City CA resident expects to assume the top job at ACBL Headquarters in Mem-

phis at the beginning of June, certainly no later than June 16.

Membership growth and retention are high on his list of goals. “The key to the future of bridge is to get more people to know and love the game the way we do,” Silber said. “I believe my background in marketing will prove helpful. I plan to work very closely with the Bridge America and Education Department people to come up with even more ideas on how to get the bridge message across to prospective members.

“There are two distinct ways to implement these goals. First, we can

Only one top seed falls in Vanderbilt

The teams captained by Richard Schwartz, Nick Nickell and Ralph Cohen had an easy time yesterday in the first round of the Vanderbilt Teams -- each had a bye. Schwartz and Nickell advanced because they were the top seeds. Cohen’s opponents never showed up.

Only one seed of the top 20, the #19 team captained by Dan Morse, failed to advance. Morse, Eddie Kantar, Steve Beatty, Adam Wildavsky, Allan Falk and Venkatrao Koneru were upset by a California team consisting of Everett Boyer, Scott Benson, Herbert Hackney and Brent Matson.

Kathie Wei-Sender, who has been the woman behind the advance of Chinese bridge, and her partner, Juanita Chambers, joined four visitors from China, and today they’re in the second round. They scored a solid first-day victory -- their opponents withdrew after three quarters. The Chinese players are Ding Yucheng, Lu Dong, Qiao Xiao Dong and Jiang Lu.

Californians lead Silver Ribbon Pairs

Two California men hold a lead of less than a full board going into today’s final two sessions of the Silver Ribbon Pairs. Donald Foote of Pasadena and Birger Holmquist of Chatsworth were the leaders, followed by William Esberg, Long Branch NJ, and Jim Hamilton, Wallingford CT, with 2381.37.

Sunday’s qualifying rounds drew an entry of 180 pairs, the largest field since the event began in 1992.

On Board 25 of the first qualifying session of Open Pairs I, Claude Vogel and George Jacobs were defending a 2♣ contract when Vogel revoked! Ordinarily this is bad -- sometimes even disastrous, but not this time! Vogel and Jacobs GAINED two tricks! Watch . . .

Claude led the ♦J, won with the king. Declarer then made a key play -- he led the ♣7 and led it ride! If he hadn't done this, Claude would have had four natural trump tricks. Of course George could have covered with the 8, but who ever heard of covering a singleton 7? Claude won with one of his honors and led another diamond.

Declarer in turn won and put Claude on lead again with a trump. Claude took this, cashed a diamond, then trapped declarer by leading the 13th diamond as George pitched a heart. Now declarer led the ♣10 -- and here we go! Claude won the trick with the ace of spades! If he had followed suit, he probably would have led a heart. Declarer would probably finesse, and George was likely to push a spade through declarer, playing Claude with two hearts and declarer for two spades. This would result in down one.

But now the ace of spades was a penalty card, and since Claude won the trick with a club honor after the director gave his ruling, Claude was forced by the Laws to continue with the ace of spades. This brought down the singleton king, so Claude continued with a second spade that declarer ruffed. Declarer now took the heart finesse, and George led his last spade, again ruffed by declarer. At this point Claude claimed since declarer had pitched spades on clubs. Claude was left with the last trump and the last spade -- down THREE.

All in all, a fortunate revoke.

Trump coup

Joan Priebe found a neat counter to a good defensive play in the finals of the Compact Knockout Teams on Friday.

West led a low spade and Joan (South) surveyed prospects in her modest 2♦ contract. She won the ♠A and led the ♦9: low, low, ace. West now led the ♥A and continued with the queen, won by dummy’s king.

Joan led the ♦8 and East won the king. East played a club to West’s ace. After cashing the ♥J, as East pitched a club, West found the best continuation -- another heart. Joan ruffed in dummy, and both East and declarer discarded clubs.

Reading the hand perfectly, Joan played three rounds of spades, pitching her last club as East followed helplessly.

A club lead from dummy at trick 12 now picked up East’s J-7 of trumps.

World Championships -- what an experience

My wife Mari and I have attended every World Championship since New Orleans in 1978. What a thrill it was playing against the best in the world and sometimes kibitzing them as they tried to reach the top. In 1978 we cheered for our hometown heroes, Eric Kokish and Peter Nagy, as they finished second in the Open Pairs.

The special World Championship that includes the major pair games plus the Rosenblum and McConnell Teams takes place every four years. We went to the Championships in Biarritz, France in 1982, in Miami Beach in 1986, in Geneva, Switzerland in 1990 and in Albuquerque in 1994. And we certainly are going to Lille in August.

The World Bridge Federation has assured us that comfortable hotel rooms will be available in the range of \$50 to \$200 per night, double occupancy including breakfast. Air France is offering discounted tickets and free fast train connections to Lille directly from deGaulle Airport in Paris.

Those who wish to rent a car will find plenty of free parking places at the Convention Centre.

Many of us will consider combining bridge with a wonderful European holiday. You should make your hotel reservations early so that you can stay near the playing site.

Personally I am already looking ahead another four years to the time when my hometown, Montreal, will welcome with open arms all the players from all over the world who will participate in the next World Championships to be held in North America.

Yale TAP pays off

Thomas McDow of Rock Hill SC heard about some youngsters who were promoting bridge on their own at Yale University. He felt that this was a good source of new teachers for the ACBL, so he contacted the late Bernard Warshauer, who at the time was the District director for District 7. Warshauer agreed, and they contacted the

ACBL, asking that a Teacher Accreditation Program be run for the Yale students.

The move has paid off handsomely, according to Ron Birnbaum of San Francisco, one of the students involved in Yale bridge. Ron has been teaching bridge classes in San Francisco, and about 20 of his recent students have joined the ACBL.

“The same is true of several others who were in that Yale group,” reports Birnbaum. “They are bringing lots of new people into bridge, and some of them become ACBL members.

Incidentally Birnbaum likes a convention conceived by McDow, and he teaches it to his advanced students. “It’s called McDow over notrump. When you’re in the pass-out seat and the last bid was 1NT, you double with a five-card suit or you bid your lowest four-card suit. Then the partnership bids up the line until they find at least a 4-3 or 5-2 fit. Overall it’s proved a winner.”

Leary becomes Grand Life Master

James Bolton Leary, an attorney from the LA area, became a Grand Life Master at the San Bernadino regional in February. This is his regional. He has won the last 28 knockout matches that he has entered at that tournament.



Leary was educated at Cornell, the University of Minnesota, and the William Mitchell College of Law. He has been an attorney for 28 years and currently specializes in estate planning.

Leary has won over 100 regional events and currently has 100 Blue Ribbon Pair qualifications and was the winner of the very first Silver Ribbon Pairs held in Pasadena in 1992. He also won the Col. Russell Baldwin trophy for winning the 1971 Secondary Swiss Teams, before this became a national event. Team games are Leary’s specialty. In the last two years Leary has won 64 team games and two pair games. Leary has also done very well at the California Capital regional, having won a team game in each of the last nine years, including two double wins and two triple wins.

Leary’s partners over the last few years have included the late Ron Andersen, the late Bob Sanderson, John Fout, and George Harris.

Leary is the originator of the NAIL Club (new and improved Leary club), an ultra-modern relay club system which includes a very large number of defensive agreements against opponent’s conventional actions.

Leary is a colorful character who is an outstanding storyteller, collects comic books and cells from animated movies. He has a large collection of Disney collectibles. He relaxes after tournaments telling stories and singing bawdy Irish folk songs.

Good technique

Fred Gitelman pointed out a nice point of technique on the following deal. You might consider it routine but as the score indicated, good technique paid dividends.

Vul: Both ♥ K J 9 8 4

Fred (South) played 4♠. On a diamond lead, he had no option but to ruff a diamond in dummy. Now he led the ♠4 from dummy and when East played low, he went up with the ♠Q.

Why did he do that? If spades are 2-2 his play is immaterial, but if spades are 3-1, the only singleton he can pick up is the jack.

The Facts: There was an agreed break in tempo before West bid 6♥. The Director ruled there was no violation of Law 16A. (“the partner may not choose from among logical alternative actions one that could demonstrably have been suggested over another”) The 6NT bid was not suggested by the unauthorized information.

The Appeal: N/S appealed the ruling. They suggested the break in tempo showed further interest, and that pass was a logical alternative for East after the break in tempo.

The Decision: The Committee decided the table result would stand. West showed maximum values when he took his side beyond game. East knew the partnership had a combined 33-34 HCP, and the heart suit was likely to produce five tricks. The form of scoring (matchpoints) made 6NT an attractive choice. This **authorized** information justified East’s bid.

Secondarily, the break in tempo did not “demonstrably suggest” a 6NT bid over a pass. West already showed extra values. The only value West did not already show was possible club shortness. That shortness might “demonstrably suggest” a 7♥ bid from East. Because 6NT was not “demonstrably suggested”, there is no reason to prohibit that action.

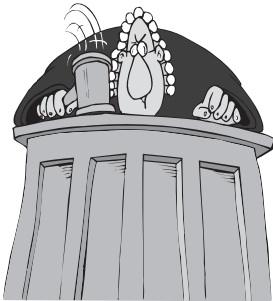
The Facts: After observing the dummy, South commented that North did not have the values for his 2♦ bid. Later South called for the Director. South said he bid 6♥ because the auction indicated North would be short in spades. The Director asked East about the meaning of his double, and he replied he was not certain of their agreement. The Director ruled that E/W did not meet their burden to show a misbid instead of a misexplanation (Law 75B) and changed the contract to 4♥, making five.

The Appeal: E/W appealed, and were the only ones who appeared. They stated the double of 2♦ showed spades and a minor, and East had misbid. In support, they produced two identically filled out convention cards and system notes explicitly stating this double showed spades and a minor. (Note: E/W did not show their system notes until the hearing.)

The Decision: The Committee decided the table result would stand. They accepted that West correctly explained the double showed spades and a minor. East misbid when he doubled 2♦. That did not violate Law 75B. (“if the opponents are subsequently damaged, as through drawing a false inference . . . , they are not entitled to redress.”)

The Committee did not assess any penalty against E/W for the misbid. Some members believed that North’s 2♦ misbid, not East’s double, was the primary reason for South’s 6♥ bid.

establish programs for social players -- people who already are involved in bridge -- so that these players will be interested in becoming part of the ACBL. Second, we can look for ways to bring new players into the fold.”

Yes, he’s a bridge player

Is Silber a bridge player? Very definitely yes! He’s been playing the game for 43 years -- ever since he was 12. Is Silber a tournament player? Very definitely no! Social bridge is his idea of fun, and he plays with friends at least once a week. He is a longtime ACBL member, but in 10 years he has accumulated only about 10 masterpoints. He expects that to change, however.

“I played with Roy Green in the Continuous Pairs this afternoon (Saturday), and I had a wonderful time. When I go to Memphis, I will be active on the club scene, even if only for research. But I hope duplicate bridge will become a hobby.”

Silber found all his opponents “incredibly friendly -- but maybe that was because Green told each pair who I was and why I was there. We played good old-fashioned bridge -- you know, strong two-bids, penalty doubles and no transfers. I think some of our opponents were surprised that our low-level doubles were for penalty.”

Silber’s interest in bridge certainly surpasses the ordinary. For the past five years, he and four of his buddies have gone on what they call a three-day “bridge retreat.” They head out on Friday afternoon and do nothing but play bridge, eat and sleep until Sunday afternoon. “We even have an engraved trophy for the winner,” said Silber. “The down side is that I’ve never won it, even though I’m the host.

“Why five players? Well, four to play and one to prepare dinner, clean up, fix drinks, etc. Of course we take turns.

“You know who came up with the idea for the retreat?” asked Silber. He answered his own question: “My wife Maryanne -- and she doesn’t even play bridge. When we were on our honeymoon 31 years ago, I tried to teach her how to play, but it didn’t work. She decided there were other things she could get interested in.

“Incidentally I’ve discovered why I couldn’t teach Maryanne, and why later I couldn’t teach my daughters, Mandy and Joanna. I looked in on Audrey Grant as she was teaching teachers how to teach. Audrey made it very clear that the first thing students want to do is to get their hands on the cards and play. So that’s the way ACBL teachers are taught to teach. When I was trying to teach my family, I tried the opposite approach -- learn all about bidding before you touch your first card. Audrey’s system works, mine didn’t.”

New challenge is exciting


Speaking of Maryanne, Silber reports that she is happy about the upcoming move to Memphis because David is so excited about his new challenge. “I haven’t been too excited about my work for a few years, but I’m very excited about the challenge the ACBL offers. Maryanne is going to check into the possibilities of using her teaching talents. She teaches English as a second language to adults. The students she is working with now speak 29 different languages, but she gets her points across using a combination of English and sign language.

“If there is nothing available along this line, then she may go for her doctorate in multi-cultures. She also may get involved in some volunteer activities.”

Silber thoroughly enjoyed his day Saturday. “I met all kinds of people who were only names in a magazine before. You know, people like Bobby Wolff and Bill Root. I bet I met at least 20 people today

who have been in the headlines or at the top of one of the lists. And I even won almost a full masterpoint -- we came in fourth in our section. It’s been highly enjoyable.”

He had another new experience late Saturday night. “I went to an appeals hearing. I intended to stay only a few minutes, but I found it fascinating -- I was there until almost three o’clock. I must say that about 90% of what they were talking about went right over my head, but I was immensely impressed with the process. The dedication of the committee members was a joy to behold. It was clear that they were willing to do whatever had to be done to make sure the appellants got their message across and to insure that the final ruling was the fairest possible.”

Interests in many areas

Bridge is a major interest for Silber, but he has many others. “I love music -- and I love to sing. I’ve sung in choirs and barbershop quartets. I really enjoy

it. And I love opera. “I used to be a good chess player, but I don’t play much any more. Come to think of it, there are a lot of similarities between chess and bridge. And I’m also very interested in politics.

“And then there’s sports -- there are several sports I follow closely. My favorites are football, soccer, cricket and college basketball.”

Cricket? Well, that’s not surprising, considering his British background. Silber is a native of England, but he has spent most of his life in such areas as Boston, Minneapolis and San Francisco. And now it’s going to be Memphis.

Perhaps as a result of his strong interest in publishing, the *Bridge Bulletin* and the *Encyclopedia of Bridge* are of major interest to Silber. “I read the *Bulletin* cover to cover every month, except the tournament results and the tournament calendar. I especially like to study the hands.”

Silber earned a law degree at Oxford University and passed the bar exams. He also holds a Master of Business Administration degree from Harvard University. His background includes considerable experience in marketing, including a position as director of marketing for the Betty Crocker Division of General Mills in Minneapolis.

More recently, he served as vice president of marketing for Portal Publications, a graphic arts publisher of posters, greeting cards, stationery and calendars. He was senior vice president and division general manager for portal before becoming president of Golden Turtle Press, a calendar publishing company.

And now he faces a brand new challenge -- moving the American Contract Bridge League into the 21st century. □

Spingold Knockout Teams and three straight wins in the Reisinger Board-a-Match Teams with the squad sponsored by businessman Nick Nickell.

“We sort of decided it’s time to move on,” said Hamman. “We’ve lost a few steps.”

The two agreed that the partnership had become stale and that philosophical differences as to bidding style contributed significantly to the move, which was initiated by Hamman.

Plans are for Hamman, 59, to stay with the Nickell team and play with Paul Soloway, a former partner and teammate from the fabled Aces teams. Wolff’s future is less certain. “There are some possibilities,” Wolff said in late February, “but I’m not thinking about them now.”

Wolff said he was surprised by the move, especially considering the team’s success of late. The Nickell team -- including Richard Freeman, Jeff Meckstroth and Eric Rodwell -- finished second to France in the 1997 Bermuda Bowl in Hammamet, Tunisia. They won the title in 1995.

“In Hammamet,” Wolff said, “the team won every match in the round-robin that Bob and I played, and we were plus IMPs in the quarterfinals, semifinals and final for all the sets we were in. The French simply outplayed us. Our record isn’t perfect, but we don’t take a back seat to anyone.”

Certainly the Nickell team’s record in the Nineties is phenomenal. Besides bringing home the 1995 Bermuda Bowl, the squad -- anchored by Hamman and Wolff -- won the Spingold in 1993, 1994, 1995 and 1996 and the Reisinger, arguably the toughest event in bridge, in 1993, 1994 and 1995.

Between them, Hamman and Wolff own 19 world championships, including seven Bermuda Bowl victories and a World Team Olympiad title. They won the World Open Pairs together in 1974 and were partners and teammates in 1988 on the only U.S. team to win the Olympiad. Wolff also won the World Mixed Teams in 1972.

Wolff was an original member of the Aces, the professional team put together by Ira Corn in 1968. Hamman joined the squad in 1969, and he and Wolff began playing together in 1972.

Hamman, No. 1 in World Bridge Federation player rankings since 1985, claims the differences with Wolff about bidding have always been there but he recently has seen changes in his own game that called for a new direction. “I haven’t been playing all that sharp,” Hamman said. “At one time, we were an overpowering pair. We’re not any more. I want to take a little more theoretical approach and less running off tackle and daring them to stop me.”

To Wolff, “theoretical” translates to “artificial,” and he wanted no part of that. “It’s not that I’m lazy or don’t want to improve our bidding,” Wolff said, “but I think an artificial system would have severely hurt our partnership.”

Hamman and Wolff play a strong 1♣ system with four-card majors. Although initial responses to the 1♣ opening are artificial, showing controls, virtually the rest of the system is natural.

Interestingly, Hamman wrote a strongly worded piece for the *Daily Bulletin* during the 1997 Fall NABC in St. Louis extolling the virtues of a primarily natural bidding system, using the French Bermuda Bowl champions as examples of success with that style. Hamman’s treatise, however, was aimed more at what he considers destructive bidding.

Such issues aside, the 64-year-old Wolff said he was chagrined at the developments and at a loss to understand what happened. “It is mystifying to me the illusions some people have about success or failure,” he said. □

Barnet Shenkin, partnered by Matt Granovetter, executed a beautiful defensive maneuver to beat an apparently laydown contract. The hand comes from the first round of the Vanderbilt. Cover the East and South hands to set yourself the same problem.

As you can see, 2♠ was fated to be held to eight tricks on club ruffs, so Shenkin was right to let 3♦ play -- but only if he could beat it!

He led a top spade and Matt discouraged. Now Shenkin wanted to play diamonds but was reluctant to give up his trump trick. He got the best of both worlds by underleading his ♥A-K! Granovetter won the queen and led a trump. Declarer won, but the best he could do was to crossruff clubs and hearts to reach this ending:

The best declarer can do is to lead the ♠Q, but Shenkin could take the king and cash the ♥A to allow Granovetter to pitch a spade. Declarer could ruff and exit with a low trump, but Shenkin could cash the ♥A, forcing declarer to ruff with the queen. Granovetter’s ♦J took trick 13.
