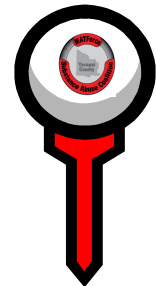

- ▶ Drop in youth alcohol, marijuana and meth use.

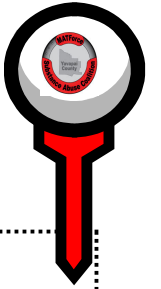
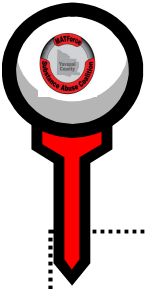
Yavapai County 12th graders report on lifetime use
