



By performing first domestic passenger flight in June 03, 2003 in the history of Mongolian Civil Aviation Transportation the list of private airlines was added by one more company named "Aero Mongolia" Co., LTD. At the first stage of its establishment the company served with Holland manufactured aircraft "Fokker-50" and about 50 personnel offering permanent flight destinations to 4 different province centers as Dornod, Khuvsgul, Uvs and Bayankhongor.

Today Aero Mongolia employs more than 130 employees possessing 2 units of Fokker-50 with 50 seats each as well as 2 units of Fokker-100 with 108 seats each in total 4 aircrafts manufactured in 1992 respectively equipped with modern and safe equipments and technologies has been serving 5 international destinations and all domestic flights in Mongolia. Erchim Corporation was established in 1974 under the name Amalgamated Repair Board and started its activity by conducting considerable repair of boilers of thermo-power stations in Darkhan city.

Timeline:

- Dec, 1989 new industrial building equipped with about 260 up-to-date machineries within 11 thousand square meters into operation
- 1995 started experiment, assemble & production of small sized boilers by setting up a Mongolian and Chinese joint venture "Zuukh" Co., Ltd
- Aug, 1996 set up a Mongolian & Indian joint venture "EMP" Co., Ltd and started producing transformers with the capacity of 25-400kw
- Oct, 1996 started producing detailed parts of high pressure of BKZ-220 boilers
- In 1998 acted as chief implementer of renewal of the thermo power plant of Zuunbayan village and put boilers UKHZ-0.7 into operation in such provinces as Zavkhan, Kharkhorin and Bayankhongor.
- Apr, 1999 operated a set of technological line to repair reels for high voltage electric machinery.

Implemented projects:

Between 1996-1999, worked as a sub-contractor of "ABB" Italian company which is the contractor of boiler renewal of Power Plant-3 and produced about 3000 tons products such as metal structure, pressure part components if 4 boilers BKZ 220-100.

In years of 1997-1999, distinguished as a contractor of international tender for boilers renewal of Power Plant-4, financed by the credit with remission of Japan and manufactured waterwall tubes & super heater of 4 boilers.

By the order of "Austria-Energy" company, we produced cyclones /3600mm*7100mm/ of 4 boilers and totally 80 tons of metal structures as well as participated in experimental and regulation measure.

Since November 2001, Monnis has held controlling share of Erchim Corporation. Within the sphere of renewal for boilers of power plant 3 and 4, we have introduced the following techniques and technology for better production:

- R/6-NOV A apparatus to make heat treatment simultaneously for 6 welding joints
- ECAB welding apparatus
- CIA tube cutter
- Non destructive testing devices for welding joints such as X-ray, radiograph, magnetic powder and liquid penetrating.

The main service of the corporation now includes regulation, assembly, repair and manufacturing of basic and auxiliary equipment for power plants.








