CANDIDATES TO SPEAK

Salinas Mayor Anna Caballero and Watsonville City Councilmember Ana Ventura Phares will be making presentations to the Club on February 18. They are running for Assembly in District 28, which includes Gilroy. Both are attorneys by profession and bring strong political backgrounds from their respective communities to the race. At one point both were attorneys with California Rural Legal Aide.

The 28th Assembly District seat is being vacated by Simon Salinas, who cannot seek reelection because of term limit laws. Salinas has now declared as a candidate for Monterey County Supervisor.

Anna Caballero has represented the residents of Salinas for the last 15 years as a Councilmember and Mayor. Recently she headed two successful campaigns to save Salinas's public libraries.

Ana Ventura Phares was a Councilmember and Mayor of Watsonville for the last 8 years. Recently she was a major player is building a third high school in the Pajaro Valley School District.

Also speaking at the meeting will be Karyn Sinunu and Marc Buller, who are running for Santa Clara County District Attorney and Santa Clara County Supervisor Pete McHugh, who is a candidate for County Assessor. These speakers are Democrats who are running for non-Partisan offices.

GOVERNOR'S BUDGET PUTS OFF DECISIONS

The Governor's recent visit to the Central Coast—where we both addressed a statewide education group—received wide news coverage. The stories largely repeated the Governor's points, understandable given California's complex and confusing education funding system.

But no matter how arcane the education finance debate may seem, unless certain fiscally responsible actions are taken this year, even tougher decisions will be needed next year.

For 2006, the Governor has proposed spending \$1.7 billion more than is required by Proposition 98 (which guides state support to public schools). He does this by taking increased revenue to the state budget from three years and spending it all in one budget year. However, on an ongoing basis, the state would spend more than it takes in.

This is where confusion really sets in. In his visit to our area, the Governor highlighted his proposal to add over \$4 billion to education next year. Problem is, all but \$1.7 billion is already required by state law. And that \$1.7 billion is just a partial down payment on what is owed to schools.

Adding to the confusion, the proposed \$1.7 billion directs money to new programs, such as music, arts, and physical and vocational education. I support these programs, but am not sure the state should mandate them while still owing local school districts over \$1 billion for programs mandated in the past.

With the state budget deficit at \$5 billion next year and almost double that the following year, it makes more sense to pay back debt owed local school districts and let them decide how best to use it.

In considering the future for our public schools, the key question is how to balance the state budget in the coming years without pitting funding for public schools against higher education, health care and support for seniors.

California's investment in education in the 1960s and 1970s was a major factor in the state becoming the sixth largest economy in the world.

As our economy continues to be challenged in a changing world, our decisions are really about whether California is going to remain economically competitive. The proposed budget just puts off that decision for another year.

County Central Committee Members and Assembly District Committee Delegates will be voting here.
