CONFIDENTIALITY AND INDEMNIFICATION AGREEMENT

Re: St. Clair Beach SC, 13430 Tecumseh Road, Tecumseh, Ontario (the "Property").

We have requested from CBRE Limited ("CBRE") through Matthew Smith, Hugh O'Connell and Brook Handysides (the "Advisor"), information, including confidential and proprietary information, which has not been generally disclosed to the public, for use in evaluating a potential purchase of the Property.

We undertake to inform such representatives of the confidential nature of such information and that they will be bound by the terms of this Agreement. We agree to be responsible for any breach of this Agreement by our representatives. We agree that any legal, financial or any other third party advisors that are retained by us, to act on our behalf, will be compensated by us. Except with the prior written consent of the Owner and CBRE, we will not contact or speak with any representatives of employees of the Owner or any tenants (or prospective tenants) of the Property.

Upon the Vendor's request, we garee to return all documentation provided herewith, including the CIM, and any notes or copies made thereof. We also agree not to use the information provided in any way detrimental to the Vendor or any parties assisting the Vendor. We acknowledge that the CIM and the other information being delivered to us with respect to the Property are subject to the limitations on liability and disclaimers for the protection of the Vendor and CBRE contained in the

We agree to indemnify and save harmless the Vendor and CBRE from any claims, losses, damages and liabilities whatsoever (including legal fees on a substantial indemnity basis and disbursements) arising out of a breach by us or any of our representatives of any of the terms or provisions of this Agreement.

This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario. All rights, entitlements, duties, and obligations arising herein shall ensure to the benefit of and be binding upon the parties to it and their respective successors and permitted assigns. We understand and acknowledge that the Advisor is acting as agent for the Owner. The undersigned understands and acknowledges the possibility of dual agency on the part of CBRE, and hereby consents to the possibility of limited dual agency during the term of this Agreement, wherein CBRE shall maintain confidentiality with respect to pricing intentions, corporate objectives and motivation.

Neither the Vendor nor CBRE shall be responsible for the payment of brokerage fees to any brokers, agents or consultants in connection with this offering other than Matthew Smith, Hugh O'Connell and Brook Handysides of CBRE.
