### BACKGROUND

Established by Allan and Gail Fujimoto to extend the reach of The Kamehameha Schools' educational mission to students of Hawaiian ancestry.

### MINIMUM ELIGIBILITY REQUIREMENTS

- Must be a Kamehameha Scholars participant;
- Demonstrate resilience through adverse conditions;
- Demonstrate perseverance and determination to strive for a college education.

### HOW DO I APPLY?

Complete the attached scholarship application and mail the application along with the following required documents to Ke Ali'i Pauahi Foundation (address on page 3) **by Monday, May 2, 2011, postmarked deadline.**

#### ***Required Documents:***

1. Completed and signed Allan and Gail Fujimoto scholarship application;
2. Copy of your college acceptance letter to an accredited college educational institution;
3. Your official High School Transcripts; and
4. Answer to the two essay questions.

***Note: late applications will not be reviewed until all other applicants have been considered first.***
