Organization of the Eagle County Conservation District

The Eagle County Conservation District was organized according to the Colorado Soil Conservation Act and is a legal subdivision of the State of Colorado. The certificate of organization was issued by the Colorado Secretary of State on November 13, 1950 and was approved by the Secretary of Agriculture on April 5, 1951.

The District governing board is composed of a seven member board of supervisors. The election, qualifications, term of office and duties shall be provided in Section 35-70-101 through 35-70-121 of the Soil Conservation Act and as provided in the Eagle County Conservation District by-laws. Sixty-six percent of the board must be actively engaged in agriculture. The Eagle County Extension Agent and Eagle County Weed and Pest manager serve as an exofficio members of the Board.

Function of the Eagle County Conservation District

To make available technical, financial and educational resources, whatever their source, and focus or coordinate them so that they meet the needs of the local land manager with conservation of soil, water and related natural resources.

Mission Statement

"Promoting the preservation and restoration of the natural resources of the District through education, cooperation, and initiation of practices that fulfill these goals."

Trends Impacting Conservation in the Eagle County Conservation District

The most significant trend impacting the District is the continual, commercial and residential development of both agricultural and forested lands. This growth raises concerns of proper use of natural resources, mainly water, as well as fire mitigation and forest health due to the extensive pine beetle infestation. There are also many new and existing acreage owners who are unaware of conservation issues such as water use, noxious weeds and soil erosion. Many of these land owners are only part year residents whose land beyond the lawn and flowers is completely unattended to.

Natural Resource Data – Area Description

The District Contains all of Eagle County except that portion of the County south of the divide which separates the drainage area of the Eagle River and its tributaries and Cottonwood Creek from the drainage area of the Fryingpan and Roaring Fork Rivers and their tributaries. It also includes the Sweetwater community in Garfield County and the lower Sheephorn community and Radium community in Grand County. The Continental Divide bounds the southeast corner of the District with the Gore Range completing the east side.

The topography of the District varies from gently sloping valley bottoms and high rolling mesas to steep timbered and Rocky Mountains. The elevation varies from 6000 feet on the lower Colorado River to the 14,000 foot peaks in the east range.

The soils are predominantly of medium texture. They are derived from sandstone, shale, gypsum and igneous rocks. They range in depth from shallow to deep. The valley soils which are being irrigated are alluvial in origin. They are generally moderately deep and quite productive. The soils on the slopes are generally deep with many stones on the surface and mixed in with the soil. The soils are derived from gypsum and are highly erodible and generally have low productivity.

The raising of livestock and irrigated farming are the most important agricultural ventures within the district. The average length of the growing season at Eagle is 85 days. The frost-free period is even shorter at some higher elevations and limits the variety of crops to those adapted to short seasons.

Natural Resource Priorities and Goals

Noxious Weeds

Goal: Increase awareness and cooperation between private land owners/managers, county officials and public land managers (BLM and USFS) to control noxious weeds.

Consistent enforcement of existing laws and regulations regarding noxious weeds.

Objective A: Work with and educate local, private landowners and managers.

Objective B: Increase effectiveness of partnership with Eagle County officials.

Water Quality and Quantity

Goal: Work to ensure best irrigation practices are used on agricultural lands. Control/minimize impact caused by development. Have plans in place to minimize and mitigate issues caused by natural occurrences or disasters.

- Objective A: Educate and increase awareness of water quality and quantity issues.

 Work to improve Irrigation Water Management (IWM) practices.
- Objective B: Work to improve water quality through reduction or management of sediments.

Land Use

- Goal: Create and maintain a better balance between developments, wildlife, agriculture, public use, and open space lands.
 - Objective A: Develop a better relationship with planning and easement officials. Review land use applications and promote conservation practices.
 - Objective B: Maintain soil and water conservation and aesthetics of open space through effective re-vegetation.

Natural Resource Information/Education Priorities and Goals

- Goal 1: Develop awareness and knowledge among students and educators regarding natural resources and local challenges.
 - Objective A: Increase water trailer demonstrations at schools, public events and the County Fair
 - Objective B: Increase awareness of scholarships available for continuing education after high school in the fields of agriculture or conservation.
 - Objective C: Continue work with Walking Mountains School to provide conservation education opportunities throughout the summer months.
- Goal 2: Educate landowners and general public about conservation issues in the District.
 - Objective A: Co-Sponsor workshops and seminars addressing local conservation issues and better practices.
 - Objective B: Promote and attend workshops in neighboring counties.
 - Objective C: Host a pastureland reseeding workshop.
 - Objective D: Publish newsletter twice yearly with informative articles and to promote workshops and programs.
 - Objective E: Host Bus Tour to showcase completed and in progress conservation projects.
 - Objective F: Public Service Announcements on ECOtv with informational ads, interviews re: conservation, weed control, etc.

Additional Conservation Activities

In addition to the goals and objectives stated in this Long Range Plan, the Board will also pursue the additional goals included in the current Annual plan. Some examples of this (from the 2014 Annual Plan) include:

- Objective A: Pursue advertisers for the newsletter and website to offset costs.
- Objective B: Maintain the website, making all ECCD activities, programs, etc. available to all interested landowners.
- Objective C: Reach out to local 4H organization to explore possible partnerships.
- Objective D: Investigate the appropriate role of ECCD in pine beetle control efforts.
- Objective E: Explore other potential partnerships and available grants to increase quality and quantity of ECCD programs and benefit to the community.

Staffing Needs

The Board is prepared to accomplish the goals and objectives stated in this Long Range Plan with the aid of one very part time (8 hours/week) District Manager. However, the District will pursue funding to enable the District Manager to be paid for 15-20 hours per week to increase our efficiency and the quality of our planned programs. The district will also pursue funding to "share" a summer weed intern already funded by neighboring Districts.

Operational Goals and Objectives

- Goal: To effectively pursue mission statement and become a recognized and valued entity within our community.
 - Objective A: The members of this board vary widely in their ages, experiences and personal philosophies regarding natural resources and need to educate each other in different aspects of conservation.
 - Objective B: Encourage use of presentations offered on the State web site.
 - Objective C: Attend and learn from co-sponsored local seminars as well as those held in neighboring districts.
 - Objective D: Pursue additional funding from Eagle County and available grants for additional staff and community programs.

Natural Resource Issue: Noxious Weeds

Why is this issue a concern and what is the location: Noxious weeds compete with desirable and native plants for natural resources, and can sicken livestock. They negatively impact both wildlife habitats and agricultural lands. A general lack of awareness among the general public, local governments, tourists and landowners, (especially first time land owners) results in continued spread of these invasive plants.

<u>Three Year Goal(s)</u>: Increased awareness and cooperation between private land owners/managers, county officials and public land managers (BLM and Forest Service) to control noxious weeds, as well as consistent enforcement of existing laws and regulations regarding noxious weeds.
