Your initial Trust Package includes your Asset Management Trust, to hold your financial assets, along with nine Sub Trusts. You may wish to establish a Gifting Sub Trust, in order to gift pre RV currencies. The remaining sub trusts should be funded post RV.

Please be advised that if you are currently involved in litigation, or reasonably expect that litigation may be pending, a Court may invalidate the protection offered by any Trust established by and for you at this time. This would also apply if you have any current Judgments against you, or if the government seeks to recover any Long Term Care or Nursing Home expenses. Each state has different rules regarding the repayment of extraordinary medical expenses.
