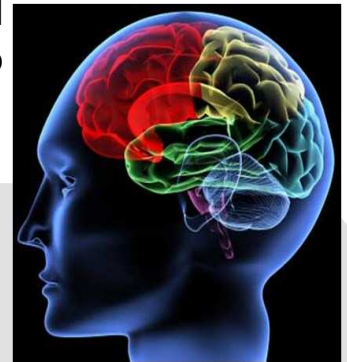


Human Factors Training Course

This two-day course is intended to provide an understanding of how human abilities, limitations and needs can be applied to the design and assessment of tasks, equipment, systems and processes, in order to reduce human error, improve safety and increase efficiency. It highlights how and why human errors occur, and describes the methods, tools and techniques that can be used to identify, analyse and reduce them.

- Justify the application of human factors to the design and assessment of tasks, equipment, systems and processes
- Compare and contrast the different types of human error and violations, and devise appropriate strategies for their prevention and reduction
- Critically review the tools and techniques available to support human error identification and quantification
- Illustrate and interpret models of accident causation, relating them to actual industrial accidents and strategies for improving safety
- Consider to what extent Human Factors can be, or have been, successfully applied to a project, facility or organisation
- Understand the key Human Factors tools and methodologies and their application and function throughout high hazard industries.

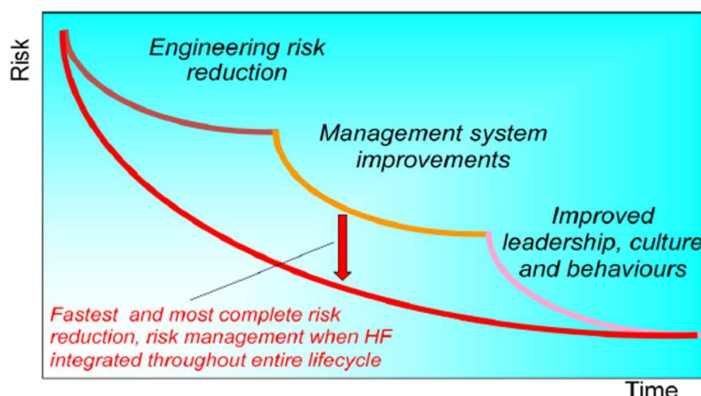
