



IMPORTANT VISA INFORMATION FOR TRAVELERS TO CHINA AND PAKISTAN

Dear Traveler,

As you prepare for your upcoming tour with GeoEx, we would like to inform you that visas are required for your visit to China and Pakistan. These visas must be obtained in advance of your departure from the United States. We have enclosed a customized instruction sheet and sample application from G3 Visas & Passports, Inc., the visa service we recommend.

As the processing times for Pakistani visas are lengthy, **we recommend that you apply for your visas 10-14 weeks prior to your US departure.** Please use a delivery service with a tracking number, such as FedEx or USPS Express Mail, when sending in your passport and documents to the visa service.

Please ensure that your passport has at least two sets of blank pages marked "Visas" and will be valid for at least six months following your tour. G3 Visas & Passports can assist with passport renewals and additional pages, if necessary. If you have other international travel scheduled during the time period that your visas will be processing, G3 Visas & Passports can assist with the issuance of a second valid US passport.

Each Traveler Must Send the Following Documents to G3 Visas & Passports:

- Your original valid signed passport. It must have at least two sets of blank pages marked "Visas" side by side and more than six months before expiry. G3 can assist with expedited passport renewals and additional passport pages.
- One CHINA visa application, completed and signed in blue or black ink. The application must be typed or completed on the attached fillable PDF and printed; handwritten applications are not accepted.
- One PAKISTAN visa application, completed and signed in blue or black ink.
- Five 2" x 2" passport size photographs, on photo paper with a plain white background, attached with a paper clip.
- A copy of confirmed international flight itinerary showing your name.
- A copy of your driver's license or a utility bill in your name showing your street address.
- A copy of a recent bank statement issued within the past 90 days. The account number may be blacked out for privacy; do not obscure any other information.
- This completed Visa Order Form; only one Visa Order Form is required per family.
- Minor visa applicants and non-US citizens are subject to additional requirements; please contact G3 for assistance.
